WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of Two hundred ninety four thousand, seven hundred and 00/100 (\$294,700.00) Dollars (of which amount \$279,700.00 is paid from the proceeds of a purchase money mortgage executed and recorded simultaneously herewith) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, William B. Baker and wife, Christine M. Baker (herein referred to as grantors) do grant, bargain, sell and convey unto Billy Lester and wife, Georgette D.
