That in consideration of Seventy Two Thousand Five Hundred dollars and Zero cents (\$72,500.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Ronald Lee Cook, a ~~man~~ man and Leisa C. Falkner, a ~~woman~~ woman (herein referred to as grantors) do grant, bargain, sell and convey unto Wade Thompson and Rachel Thompson (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:
