THIS TRANSFER AND ASSIGNMENT OF NOTE AND COLLATERAL ASSIGNMENT (hereinafter referred to as the "<u>Assignment</u>") is executed effective as of March 6, 2012, by Graham Mortgage Corporation, a Texas corporation (hereinafter referred to as "<u>Assignor</u>"), whose mailing address is 3838 Oak Lawn Avenue, Suite 1500, Dallas, Texas 75219, to First Class Homes, Inc., a Texas corporation, (hereinafter referred to as "<u>Assignee</u>"), whose mailing address is 3838 Oak Lawn Avenue, Suite 1500, Dallas, Texas 75219.

RECITALS

A. Assignor is the holder of that certain Note made by Oakmont Pool 50, LLC, a Texas limited liability company (the "Borrower"), dated November 25, 2009, in the original principal face amount of \$355,000.00 (the "Note"), secured by that certain Collateral Assignment of Notes and Liens of even date with the Note, executed and delivered by Borrower to Assignor (the "Collateral Assignment"), which conveys a first lien against certain notes secured by those liens described on Exhibit A attached hereto (the "Property") and in conjunction therewith William B. Grant executed a Guaranty

guaranteeing the Note (the "Guaranty") (herein the Note, Collateral Assignment and Guaranty are collectively referred to as the "Loan Documents.")

Assignor desires to assign to Assignee the Loan Documents, and all liens and security interests in the Property created by or arising out of the Loan Documents and all other documents evidencing, securing or relating to the loan made pursuant to the Loan Documents.

NOW, THEREFORE, know all men by these presents, that for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid to Assignor by Assignee, the receipt and sufficiency of which consideration are hereby acknowledged and confessed, Assignor does hereby SELL, TRANSFER, ASSIGN, CONVEY, ENDORSE and DELIVER unto Assignee the Note, the Collateral Assignment, the Guaranty, and all other liens and security interests in the Property created by or arising out of the Loan Documents and all other documents evidencing, securing or relating to the loan made pursuant to the Loan Documents, without recourse, representation or warranty of any kind or character, whether express or implied.


