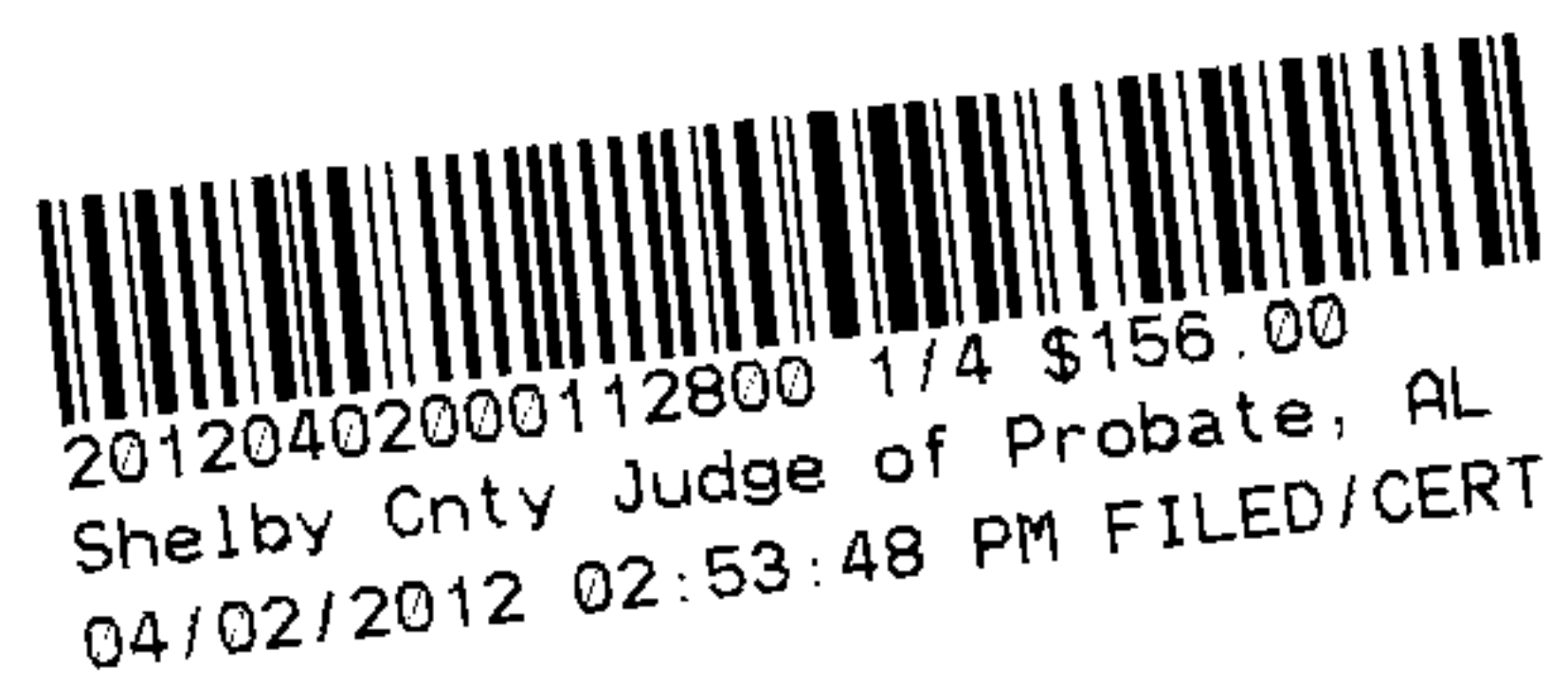
- (1) Perpetual

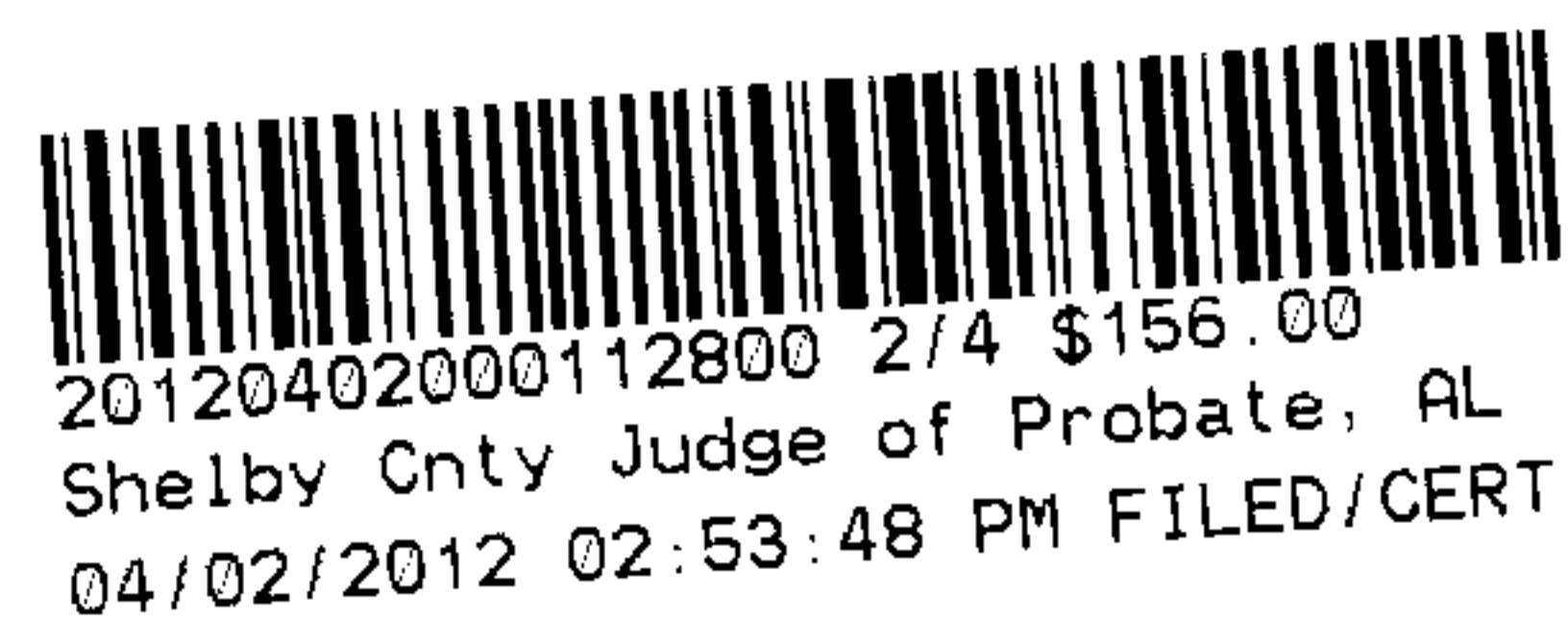
