

SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF JEFFERSON

Whereas, Joshua W. Hobbs and Jan Q. Hobbs (hereinafter referred to as "Debtors") have an outstanding Mortgage in favor of Superior Bank, now known as Cadence Bank, (hereinafter referred to as "Creditor") on certain real property described therein to secure an indebtedness, and said lien is in full force and effect; and; whereas, Debtors, have made an application to Wells Fargo, for a Mortgage loan in the sum of \$167,433.00 and said Wells Fargo. is willing to make said loan to the said Debtors, provided they furnish it with a mortgage on the lands described in the aforesaid lien, and the said Creditor subordinate the above described Mortgage and make the same second and subservient to the mortgage of Wells Fargo, and;
