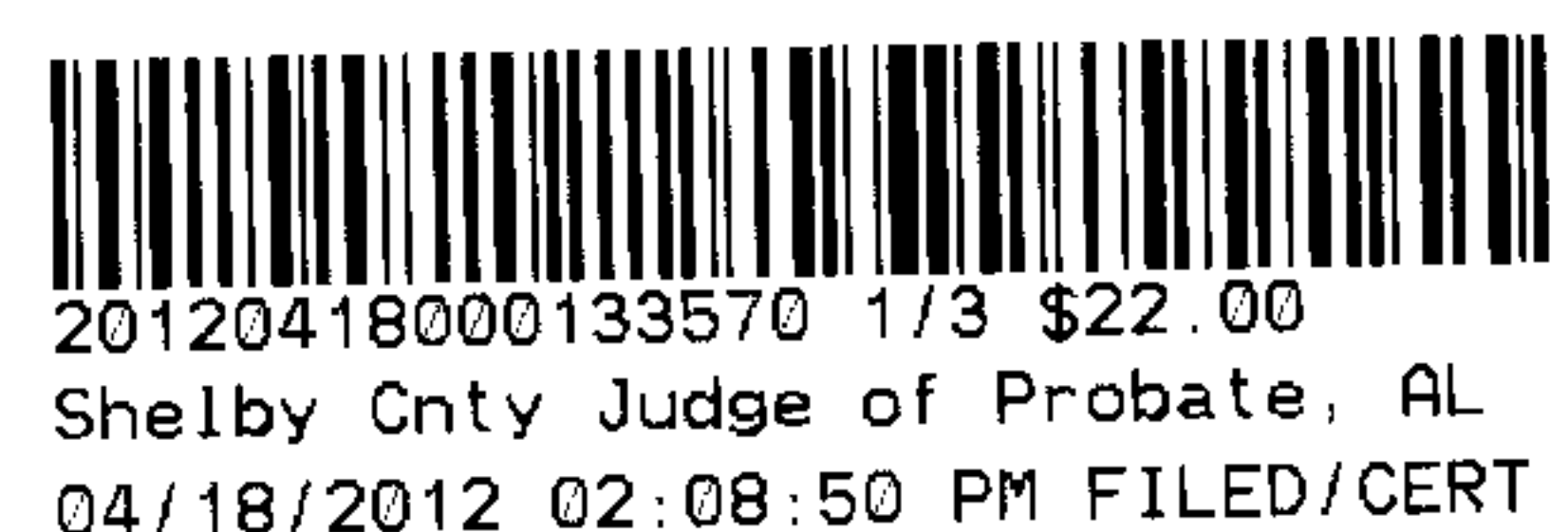
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 13th day of June, 2006, Joshua D. Kramer an unmarried man, as his sole & separate property, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for Bluestar Mortgage, Inc., A Alabama Corporation., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060615000285110, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC., by instrument recorded in Instrument No. 20110909000266820, in the aforesaid Probate Office ("Transferee"); and
