

ARTICLES OF ORGANIZATION OF BLADES OF GLORY, LLC.

1. NAME OF COMPANY. The name of the Company is:

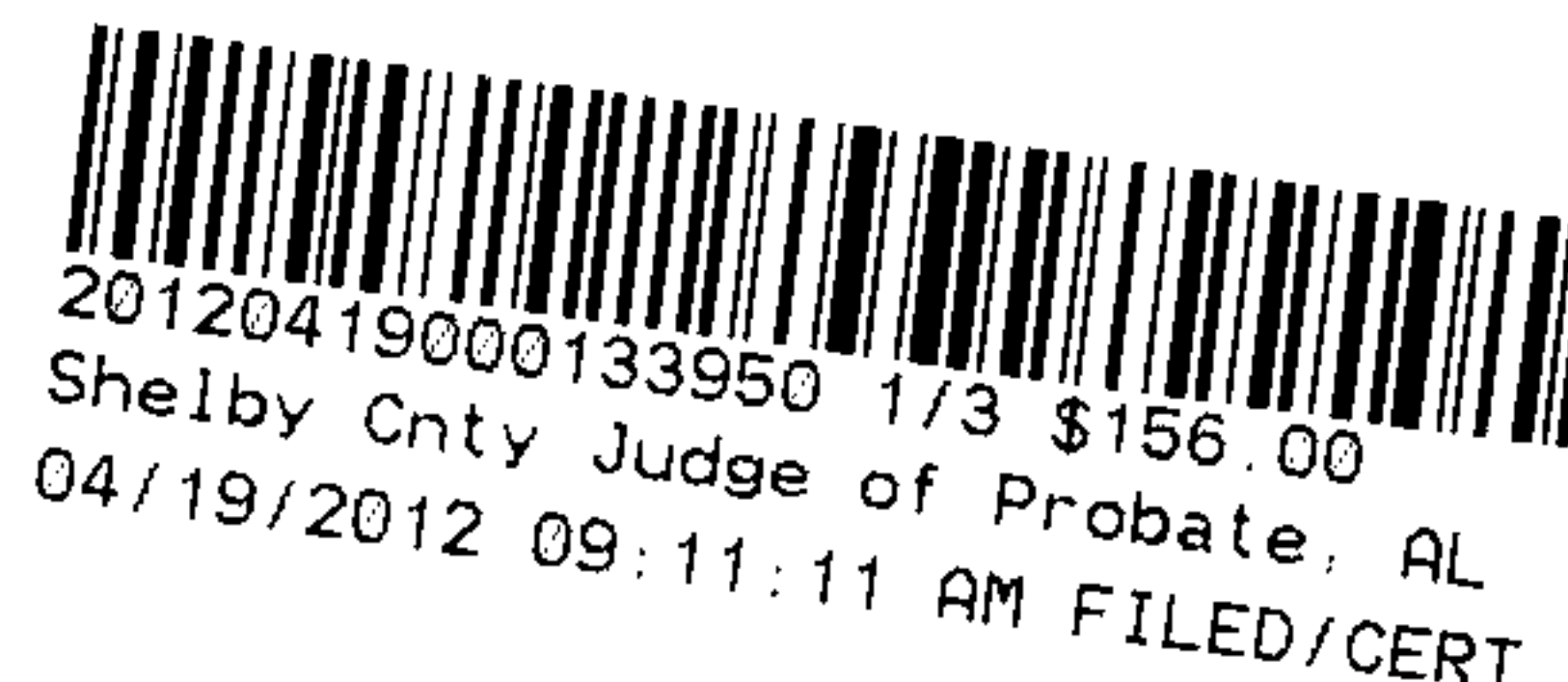
"BLADES OF GLORY, LLC."
