**Articles of Organization
of

The undersigned organizer, desiring to form a limited liability company pursuant to the laws of the State of Alabama, hereby certifies as follows:

1. **Name.** The name of the entity is Shelby OB, LLC.
2. **Type of Entity.** The type of entity being formed is a limited liability company.
3. **Purpose.** The purposes for which this limited liability company is organized are to invest in real property and enter into the operating agreement of a limited liability company, and to do any and all things necessary to own and operate said business.
