Know All Men by These Presents: That in consideration of **One hundred forty seven thousand four hundred and no/100 (\$147,400.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Embassy Homes, LLC, an Alabama Limited Liability Company** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Gerald A. \$117,920.00 of the purchase price recited above was paid from a purchase money mortgage loan closed simultaneously herewith.


This instrument is executed as required by the Articles of Organization and Operating Agreement and same have not been modified or amended.
