The purpose for which the Corporation is organized is

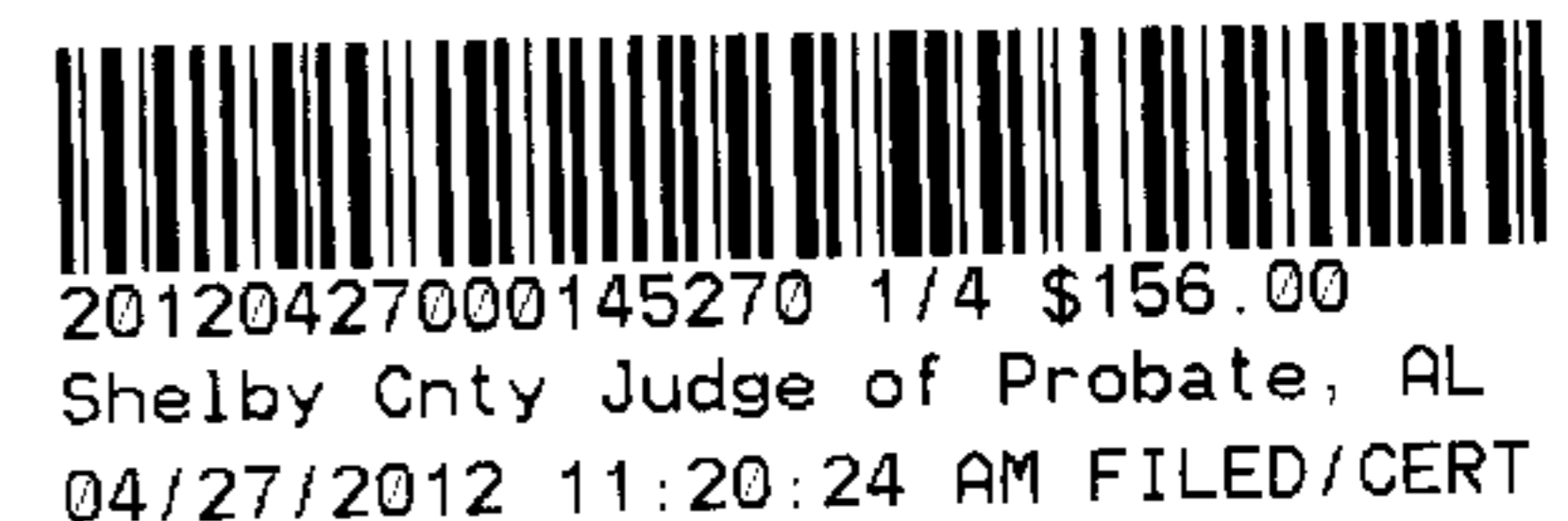
1. To manage and operate restaurant and pub; and


