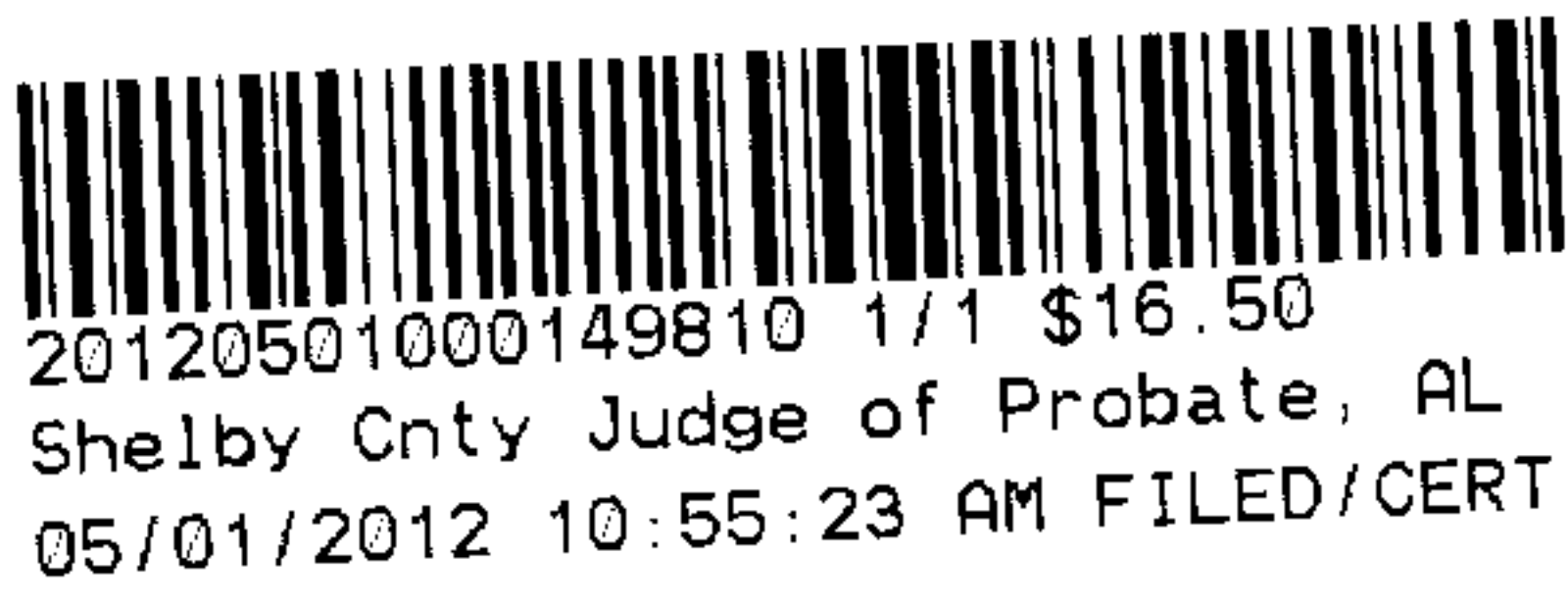


Subject to taxes for 2012 and subsequent years, easements, restrictions, rights of way, and permits of record.
