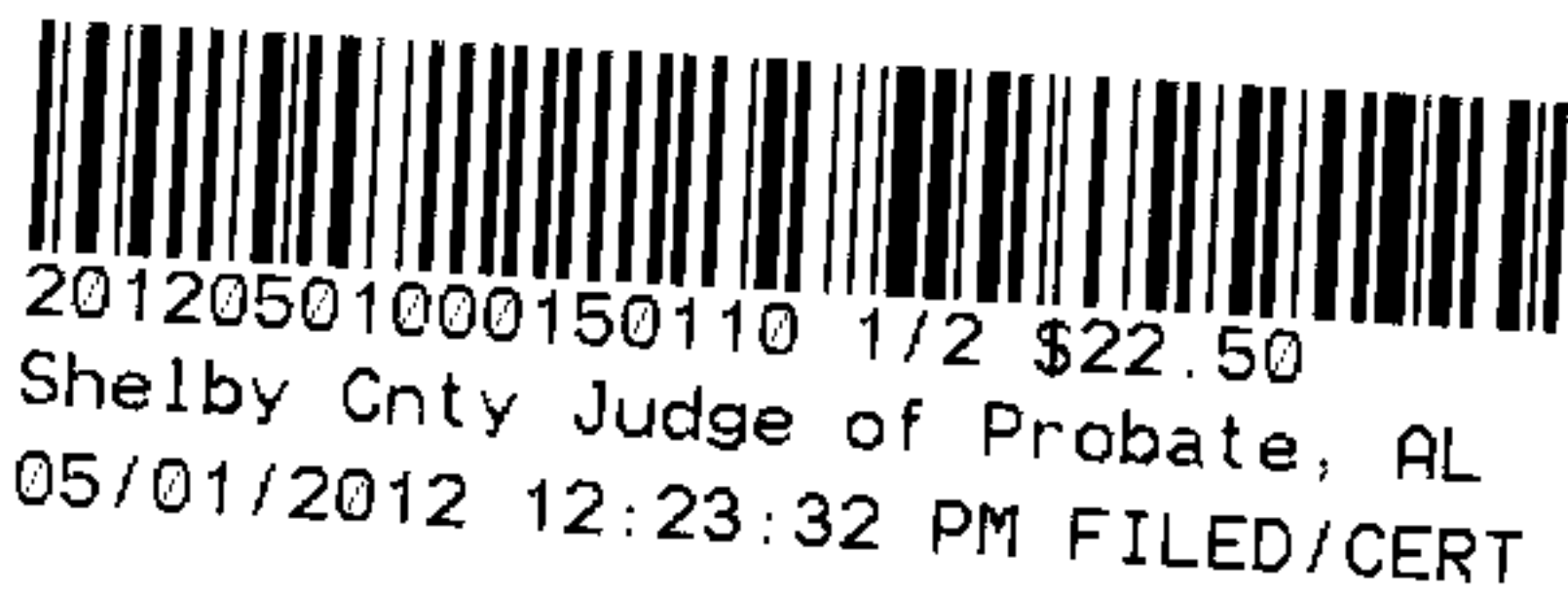
That in consideration of Two Hundred Thirty-one Thousand One Hundred Ninety-two and no/100

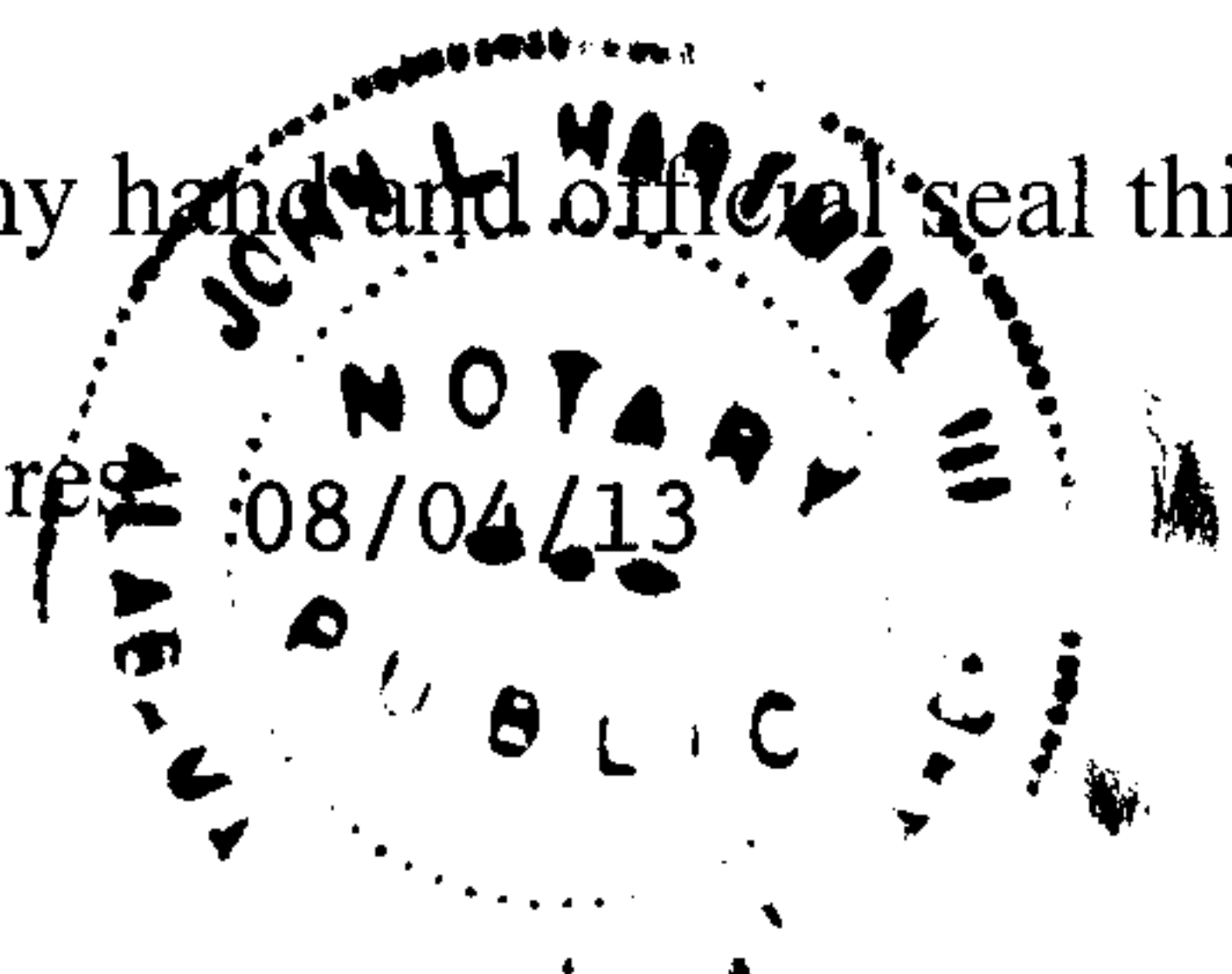
