

ARTICLES OF ORGANIZATION

OF

Pursuant to Section 10-21-1, Code of Alabama (1975) et seq., the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I B NAME

The Name of the Limited Liability Company shall be Level E Productions, LLC (the ACompany@).

ARTICLE II B DURATION

The period of duration of the Company shall be perpetual, unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the AAct@).

ARTICLE III B PURPOSES

The Limited Liability Company has been organized to engage in the business of production management by providing theatrical, musical and television production services, all related activities thereto, and any other lawful business the members shall reasonably decide to pursue. The Limited Liability Company shall have all powers permitted by the Act, as amended from time to time.

ARTICLE V B INITIAL MEMBERS




