



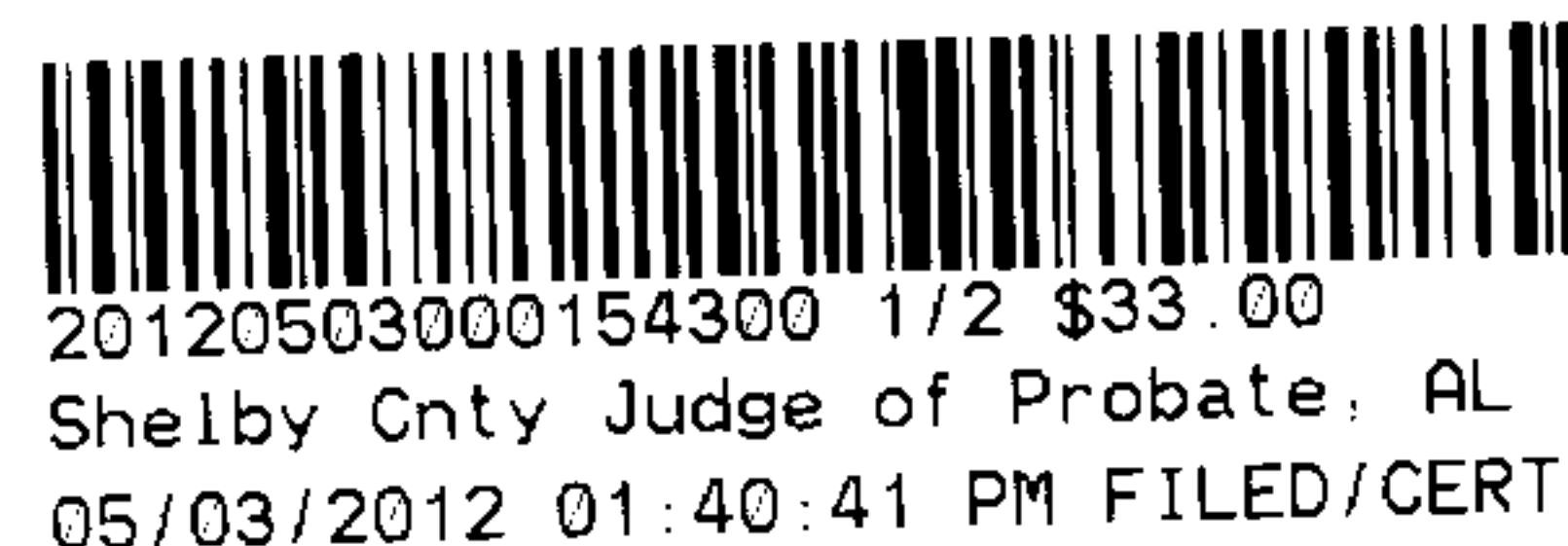

# POWER OF ATTORNEY
