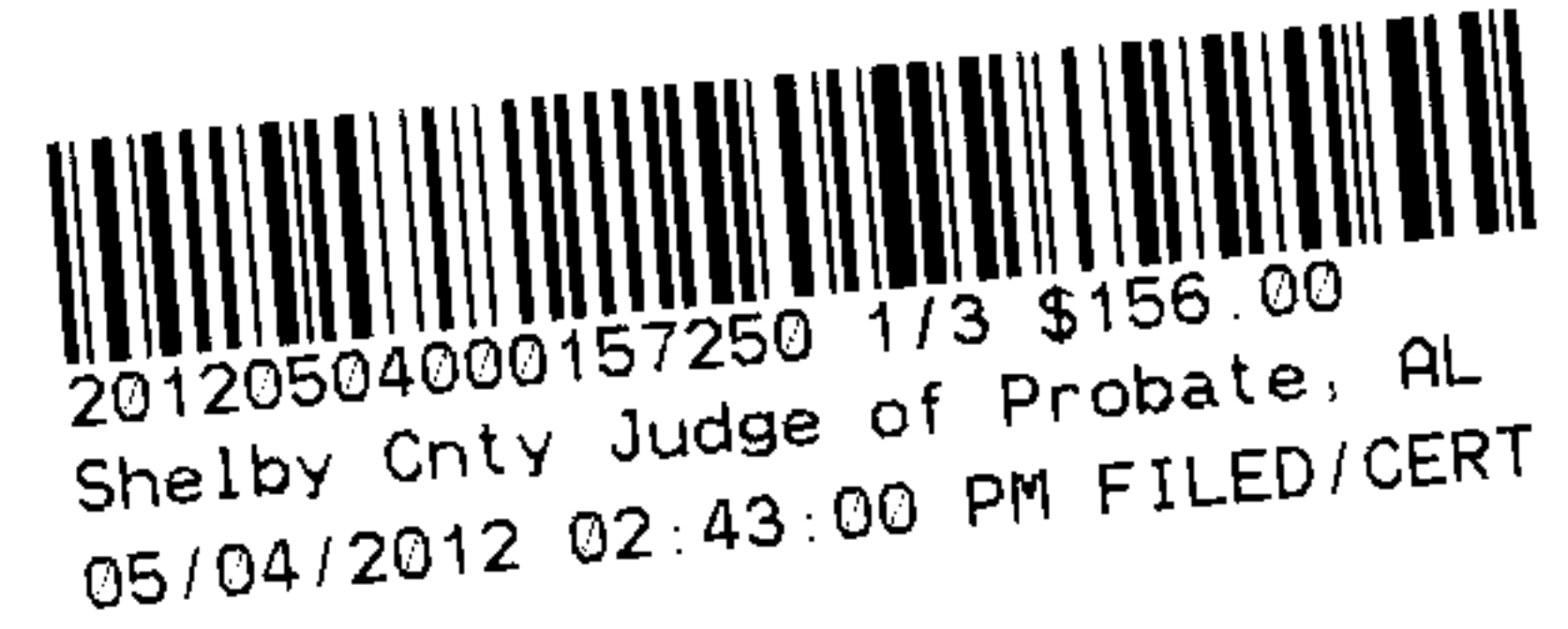


ARTICLES OF INCORPORATION
OF
JUMPY, INC.



The undersigned, in order to form a business corporation for the purposes hereinafter stated, under and pursuant to the provisions of the *Alabama Business and Nonprofit Entity Code*, hereby adopt these Articles of Incorporation (sometimes referred to "Certificate of Formation") and certify that:

1. The name of the corporation (hereinafter referred to as the "Corporation") is ***Jumpy, Inc.***

2. The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under the *Alabama Business and Nonprofit Entity Code*, including, but not limited to owning, developing, and managing entertainment facilities.

3. The duration of the Corporation shall be perpetual.

4. The initial registered agent of the Corporation is Issac David, and the initial registered office of the Corporation is located at 157 Resource Center Parkway, Suite 109, Birmingham, Alabama 35242.

5. The name and address of the incorporators of the Corporation are Issac David, 157 Resource Center Parkway, Suite 109, Birmingham, Alabama 35242, and Zaheen Tamara Khan, 4561 Bud Holmes Rd., Pinson, AL 35126.

6. There shall be one class of stock, and the Corporation is authorized to issue One Thousand (1,000) shares of common stock.

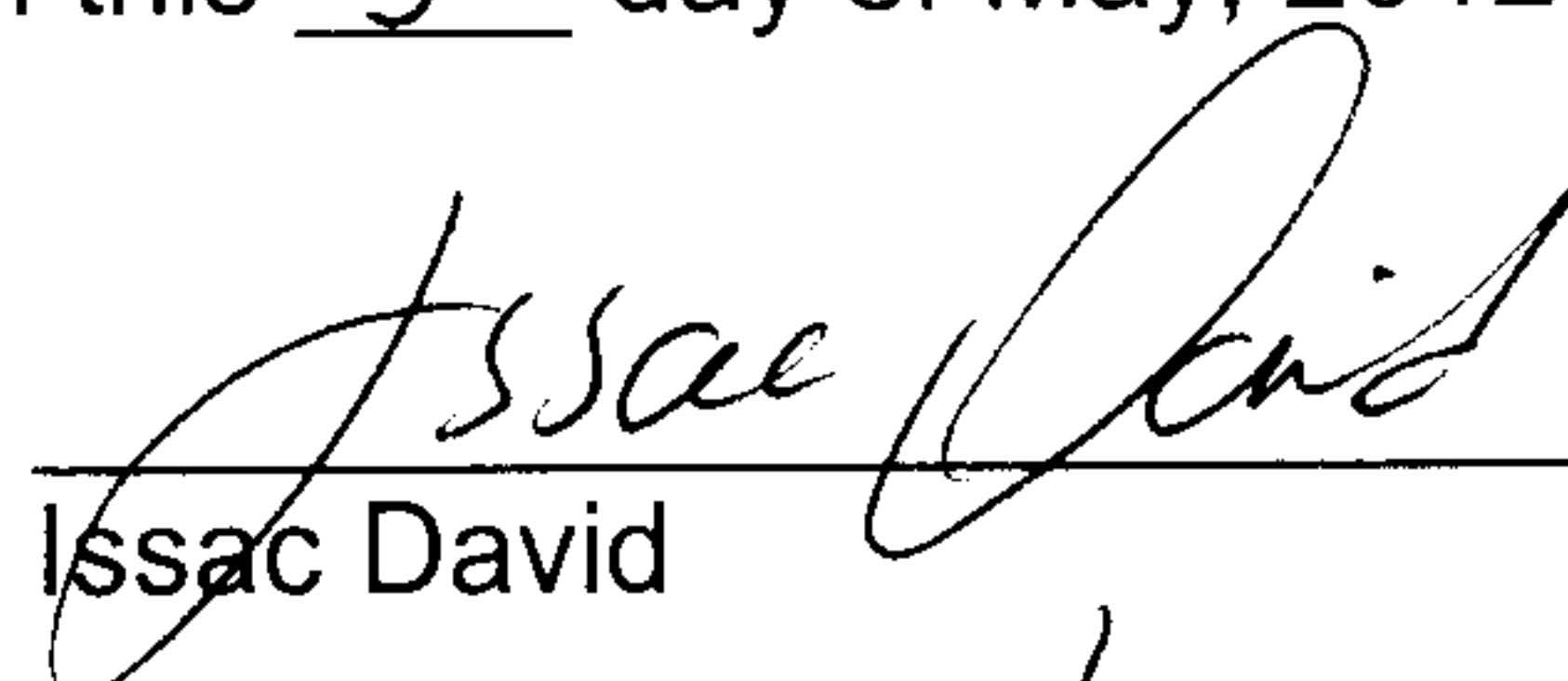
7. The initial Board of Directors shall consist of two persons. The names and addresses of the initial directors are: Issac David, 157 Resource Center Parkway, Suite 109, Birmingham, Alabama 35242, and Zaheen Tamara Khan, 4561 Bud Holmes Rd., Pinson, AL 35126.

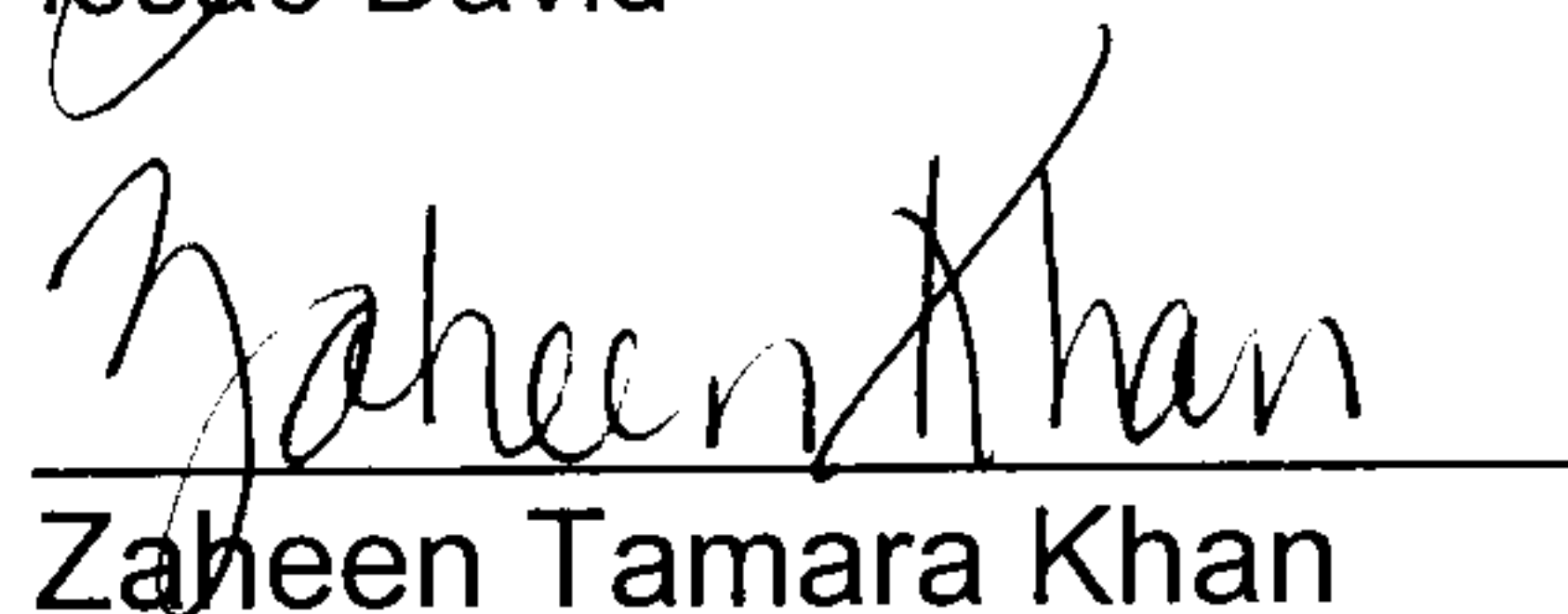
8. The Board of Directors of the Corporation, acting by majority vote, may adopt, alter, amend, or repeal the By-Laws of the Corporation.

9. The shareholders shall have preemptive rights as provided in Section 10A-2-6.30, *Code of Alabama, 1975*.

10. Except as otherwise provided by the *Alabama Business and Nonprofit Entity Code* as the same exists or may hereafter be amended, no director of the Corporation shall be personally liable to the Corporation for monetary damages for any action taken or any failure to take any action. Any repeal or modification of this provision by the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.
