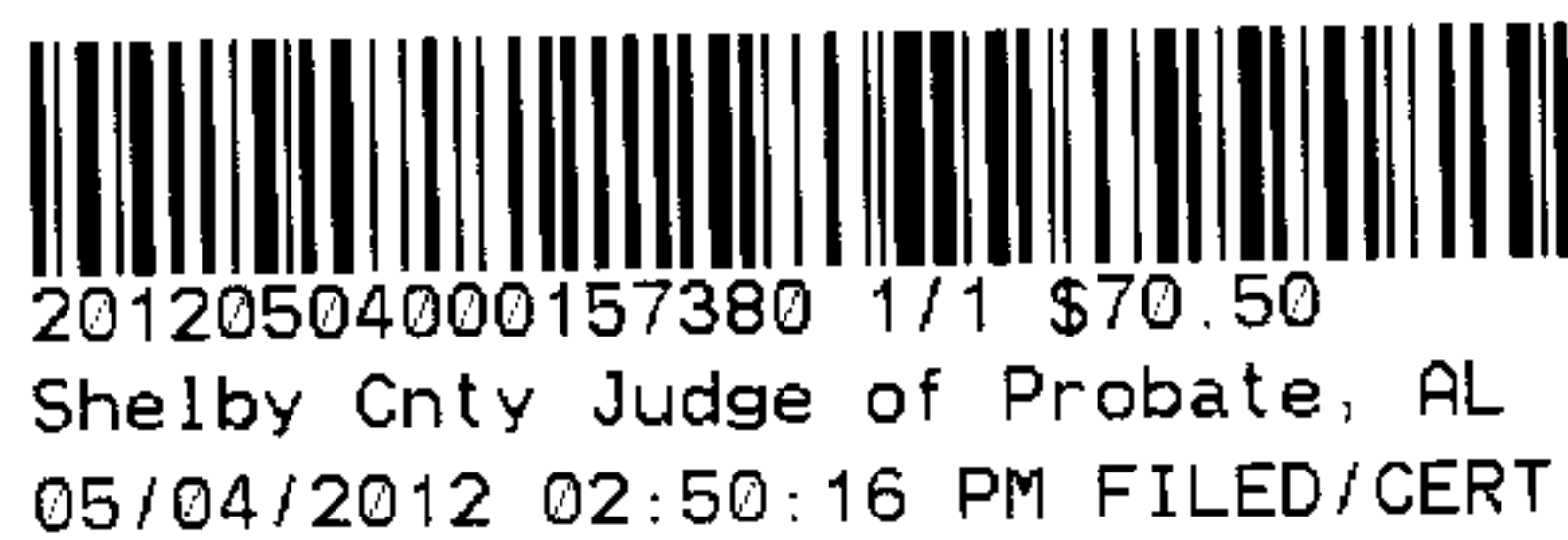

(herein referred to as grantors) do grant, bargain, sell and convey unto

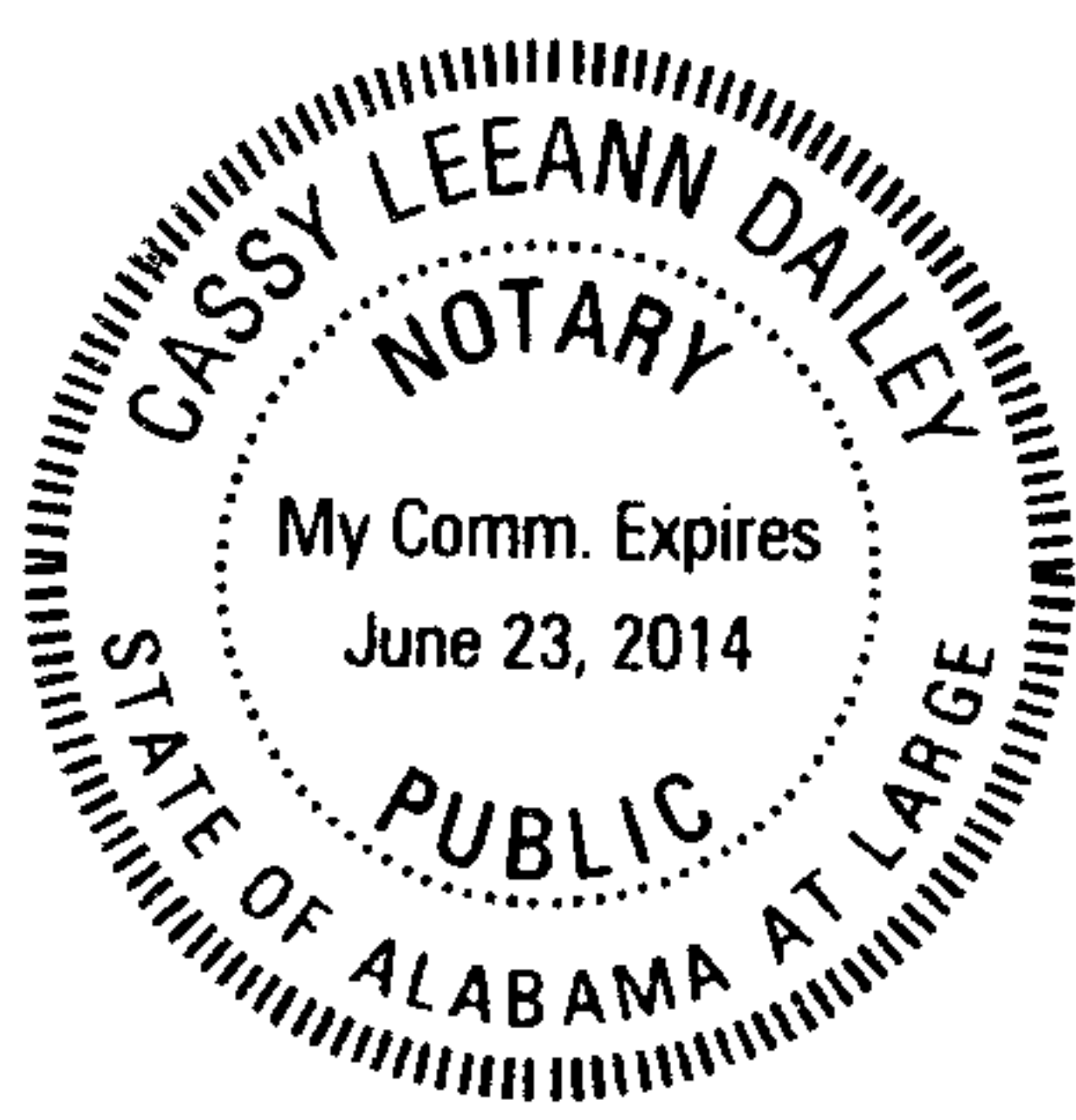
