

**ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under the Alabama Limited Liability Company Act, adopts the following Articles of Organization for the limited liability company:

5. The name and mailing address of the initial members are as follows:



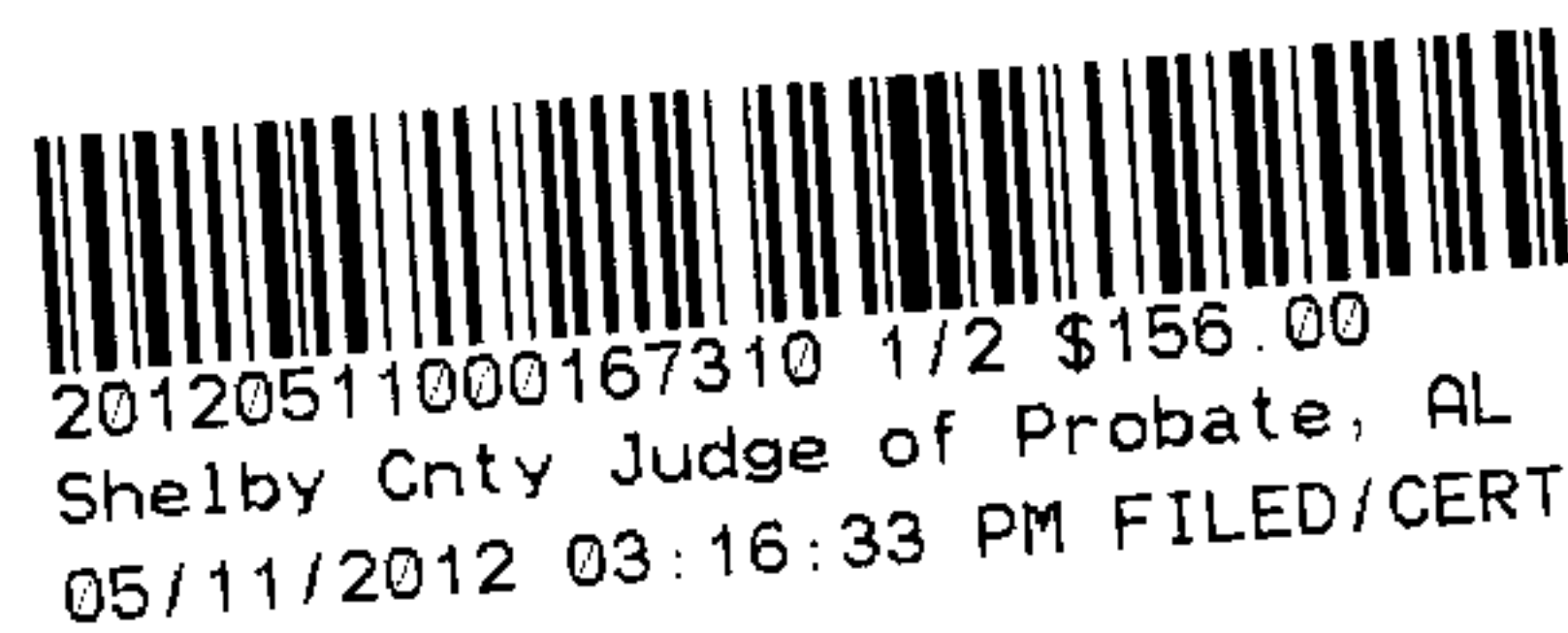
