The undersigned organizers, desiring to form a limited liability company pursuant to the laws of the State of Alabama, hereby certify as follows:

1. **Name.** The name of the entity is Meadow View Apartments, LLC.
2. **Type of Entity.** The type of entity being formed is a limited liability company.
3. **Purpose.** The purpose for which this limited liability company is organized are to acquire, own, manage, lease and otherwise transact business with respect to real property, and to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.


7. **Admission of Additional Members.** The members of the limited liability company shall have the right to admit additional members to the limited liability company, as provided in the Operating Agreement.
