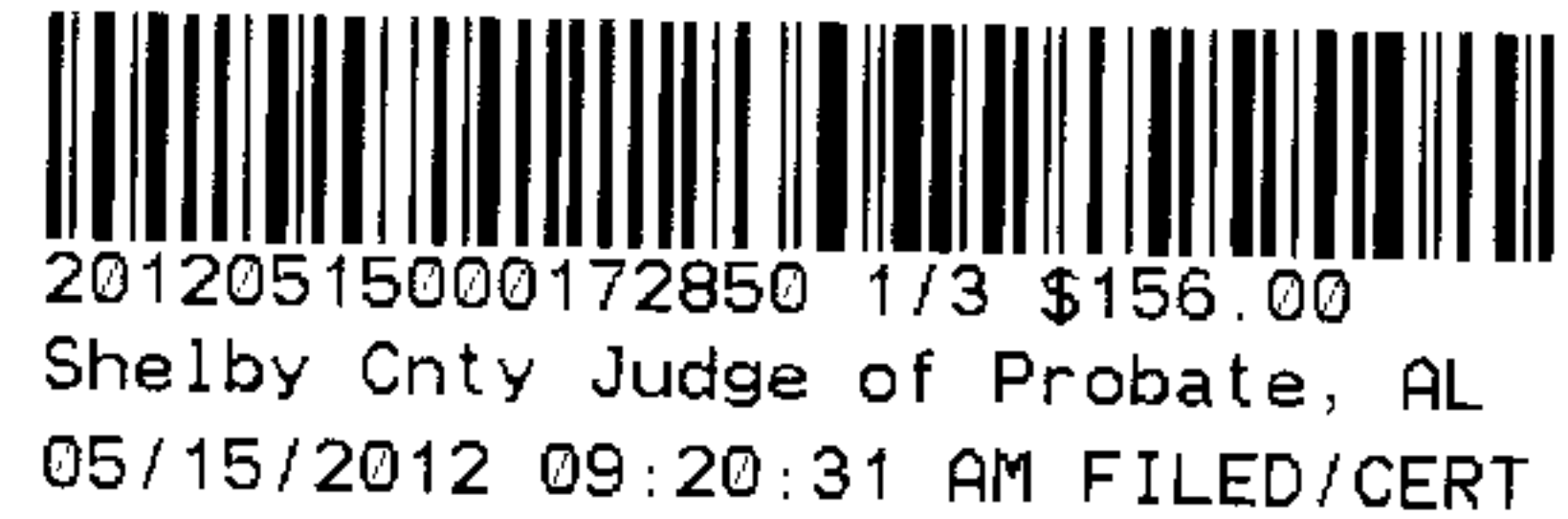


ARTICLES OF ORGANIZATION

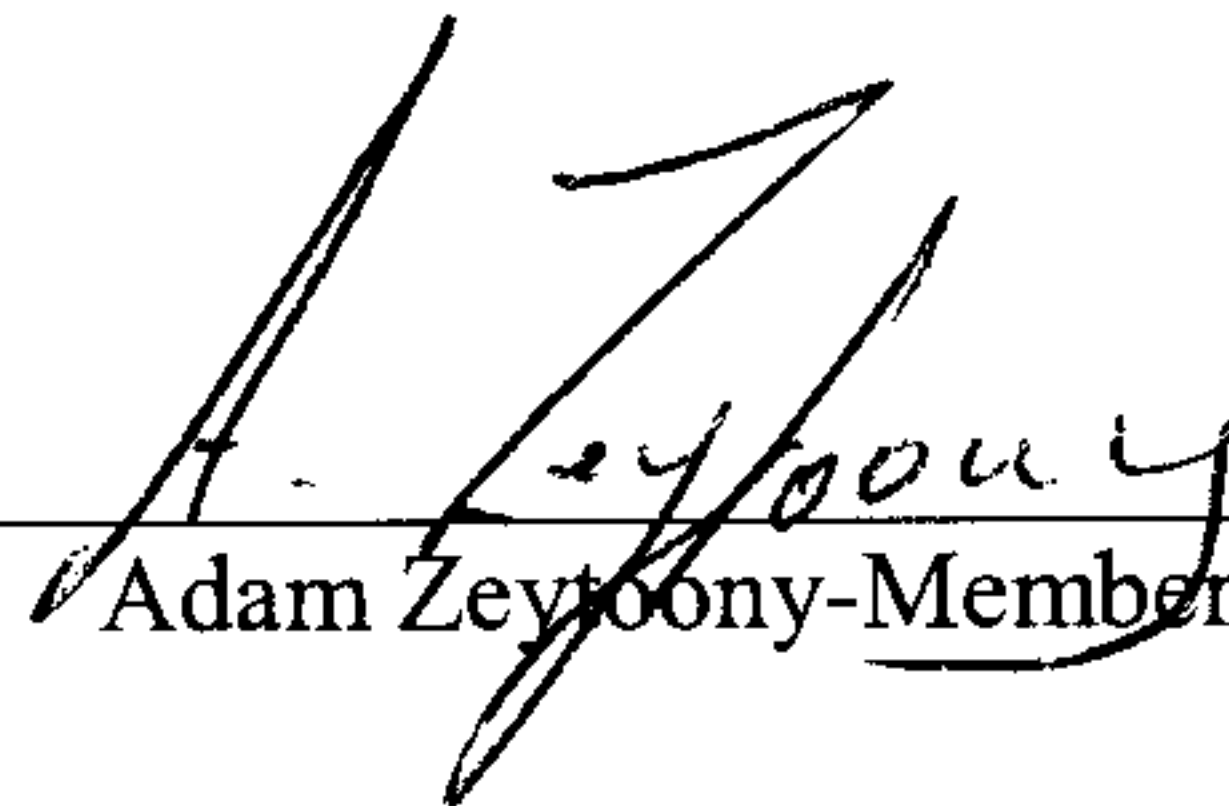

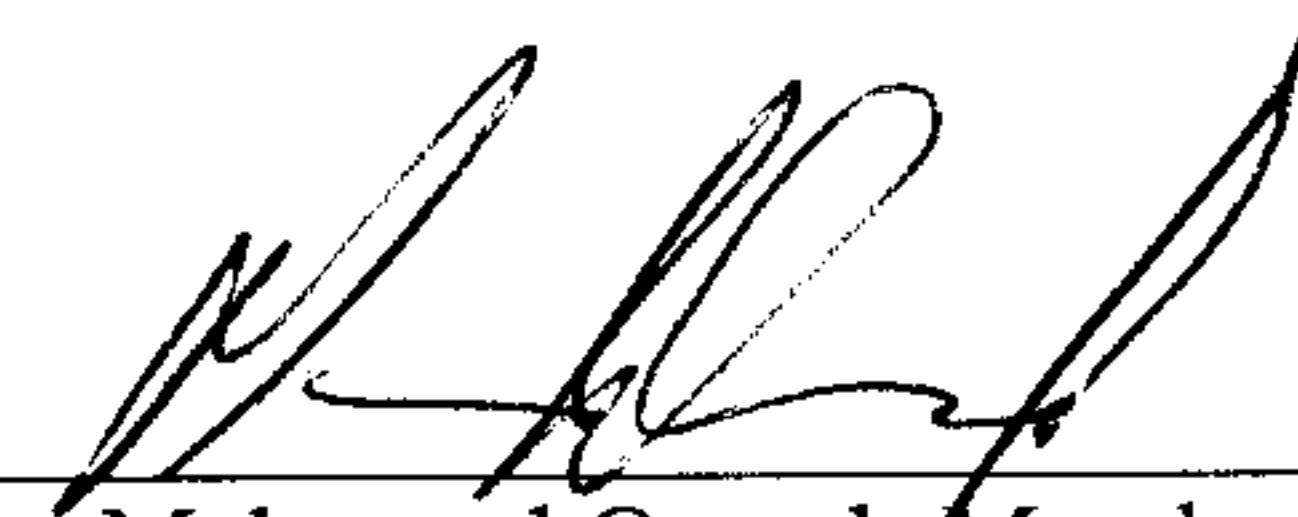
