WHEREAS, heretofore, on, to-wit: the 20th day of August, 2004, Todd L Wilson, a married person, and Diana L. 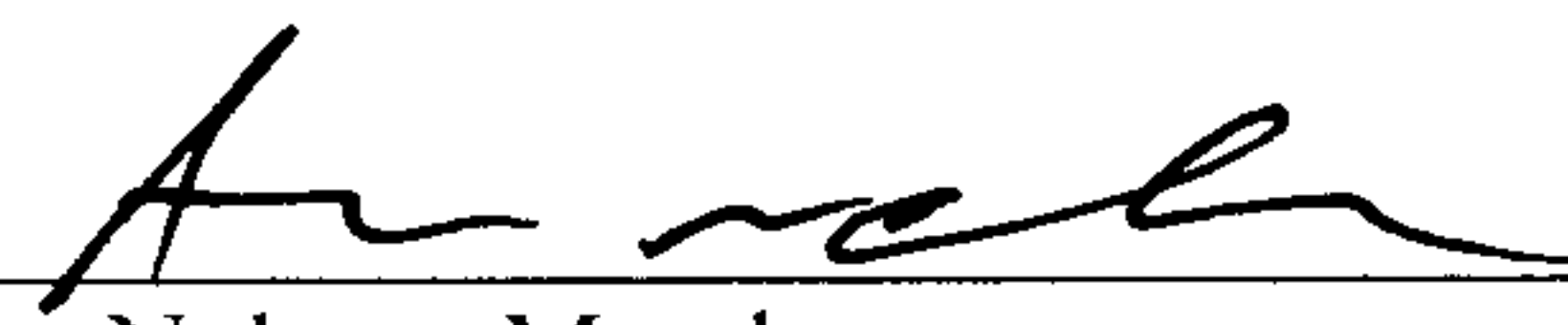

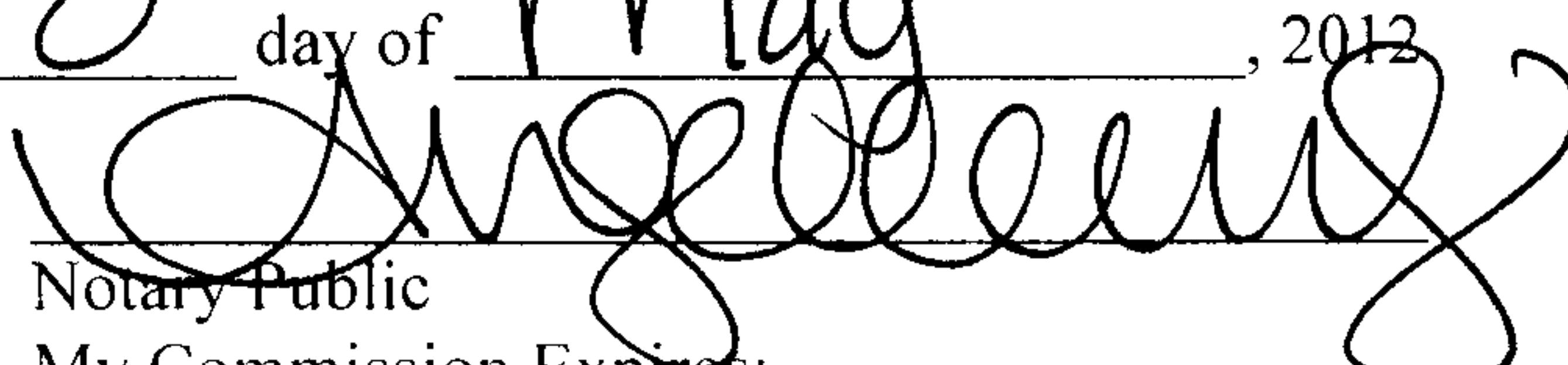
