AUCTIONEER'S DEED

WHEREAS, MOHAMMED AZIZUDDIN, a married man and wife, WAHAJ SULTANA and MOHAMMED YOUSUFUDDIN, a married man executed a mortgage to Mortgage Electronic Registration Systems, Inc. 
