Know All Men by These Presents: That in consideration of **One hundred twelve thousand and no/100 (\$112,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Luis A. Breckenridge, an unmarried man and Marilou Elchlepp, an unmarried woman** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Denmon Dukes and Clarice Dukes** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama, to-wit:**


Subject to mineral and mining rights if not owned by Grantor.

And I (we) do, for myself (ourselves) and for my (our) heirs, executors and administrators, covenant with said grantee, his, her or their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise stated above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will, and my (our) heirs, executors and administrators shall warrant and defend the same to the said grantee, his, her or their heirs and assigns forever, against the lawful claims of all persons.


