STATUTORY WARRANTY DEED

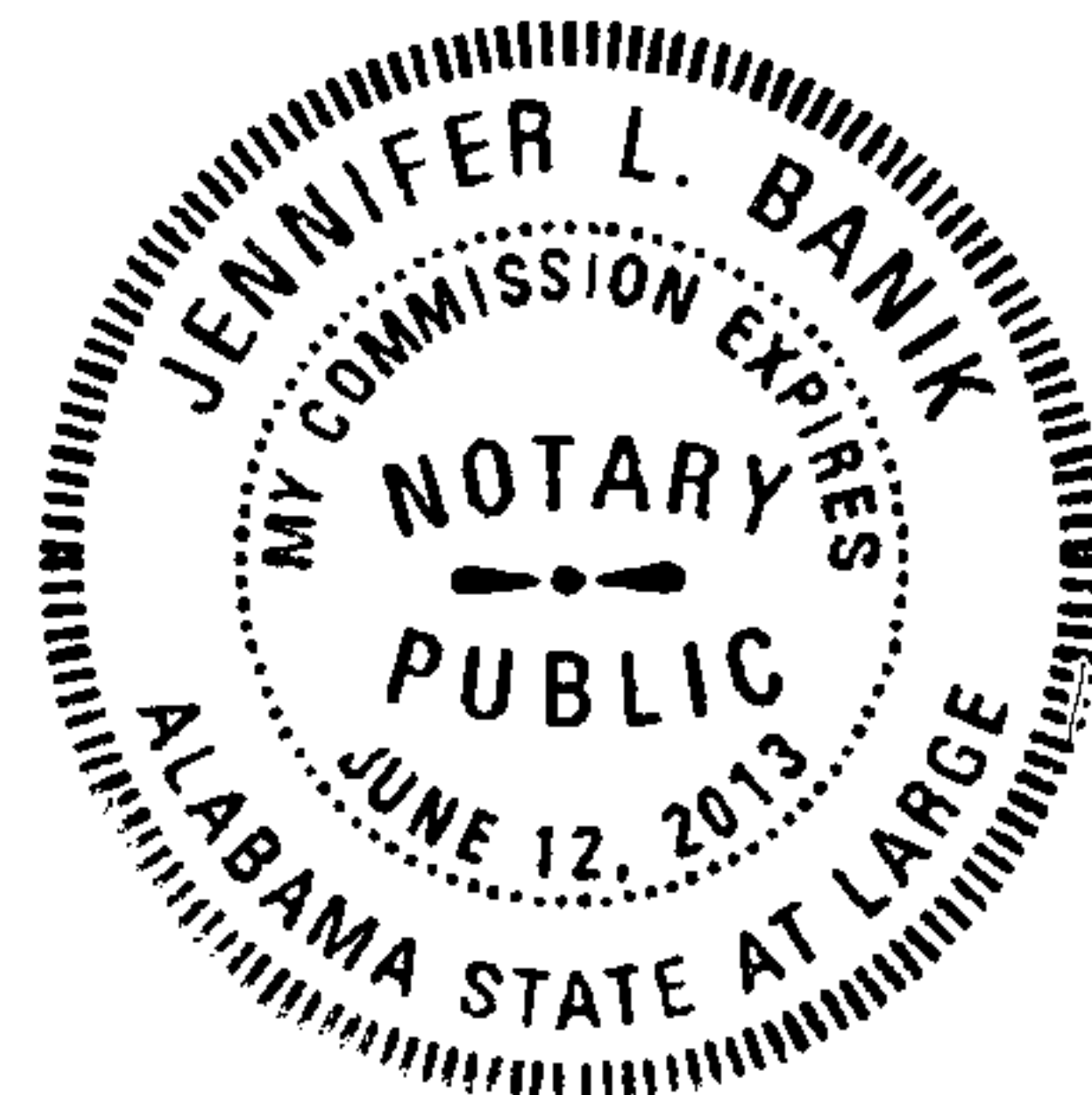
