

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
TECHNOLOGY ON DEMAND, LLC**

Pursuant to the provisions of Section 10A-5-2.03 of the Code of Alabama 1975, as amended, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the Corporation is Technology on Demand, LLC (the "Company").

SECOND: The following amendments to the Articles of Organization were adopted by the Member of the Company on the 2nd day of April, 2012, in the manner prescribed by the Alabama Limited Liability Company Law:

WHEREAS, all of the members of the Company desire to change the name of the Company from Technology on Demand, LLC to Perspectus Corporation, LLC;

NOW, THEREFORE, BE IT RESOLVED, by all of the members of the Company, pursuant to the requirements of Section 10A-5-2.03, Code of Alabama 1975, that the name of the Corporation be changed from Technology on Demand, LLC to Perspectus Corporation, LLC; and,

RESOLVED FURTHER, that the first article of the Articles of Organization of the Company be amended to read as follows:

ARTICLE I

The name of the limited liability company is Perspectus Corporation, LLC (the "Company").

RESOLVED FURTHER, that that the members of the Company hereby authorize Scott W. Gosnell, as a member, general counsel and chief operating officer, to execute any and all documents on behalf of the Company which are necessary or convenient to effectuate the foregoing resolutions.

THIRD: The number of members of the Company at the time of such adoption was two (2) members, and the number of members entitled to vote thereupon was two (2) members.

FOURTH: The number of members which voted for such amendment was two (2) members; and the number of members which voted against such amendment was zero (0) members.


