FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of May, 2005, Kimberly L. Deleon, unmarried , executed that certain mortgage on real property hereinafter described to Wells Fargo Bank, N.A., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20050512000228300; Scrivener's Affidavit recorded in Instrument No. 20050719000359390, said mortgage having subsequently been transferred and assigned to Citibank, N.A., as Trustee for LXS 2005-3, by instrument recorded in Instrument No. 20120103000001980, in the aforesaid Probate Office ("Transferee"); and

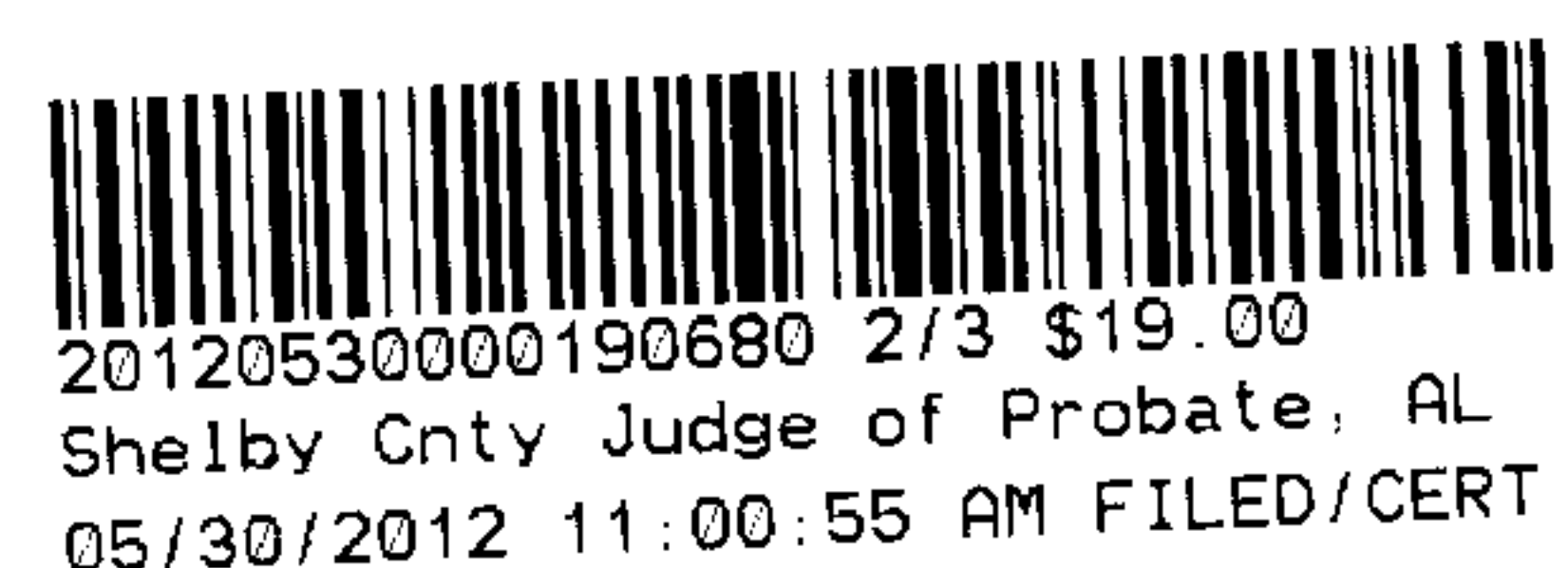




