KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of May, 2008, Craig Alcon and Andrea Alcon, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Superior Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080514000196220, said mortgage having subsequently been transferred and assigned to Bank of American, N.A. successor by merger to BAC Home Loans Servicing, L.P. FKA Countrywide Home Loans Servicing, L.P., by instrument recorded in Instrument Number 20111221000386390, in the aforesaid Probate Office ("Transferee"); and

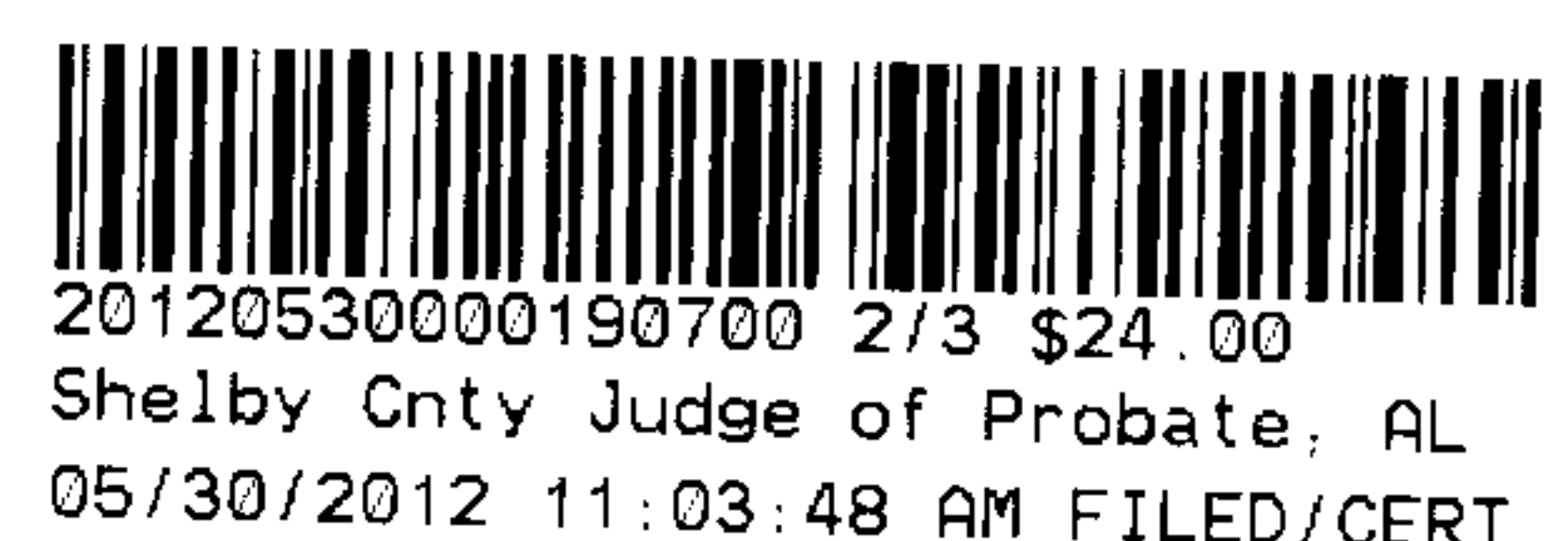
