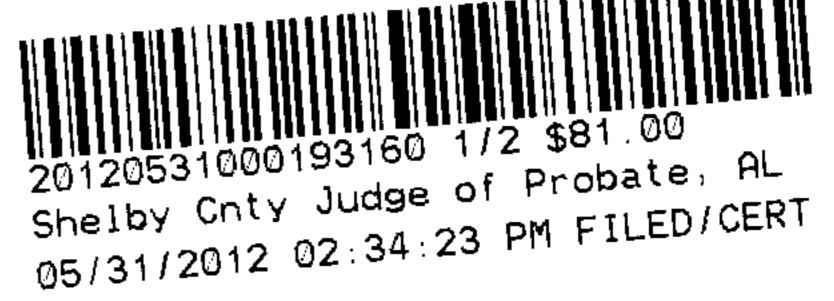
ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF EXCEL MD, INC.

TO THE HONORABLE JUDGE OF PROBATE OF



SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Business Corporation Law, the undersigned corporation executes the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the entity is Excel MD, Inc., an Alabama corporation ("Corporation").
- 2. The Corporation's articles of incorporation were filed on June 3, 2010, with the Judge of Probate of Shelby County, Alabama ("Articles of Incorporation").
- 3. Section 1.1 of the Articles of Incorporation is hereby amended by deleting it in its entirety and inserting in lieu thereof the following:
 - "1.1 The name of the Corporation will be BCSold, Inc."
- 4. The foregoing amendment to the Articles of Incorporation was adopted by the Corporation's shareholders on April 2ω , 2012, in the manner prescribed by the Alabama Business Corporation Law and the Corporation's governing documents.
 - a. The number of shares of common stock outstanding at the time of the adoption was two hundred (200), and the number of shares entitled to vote thereon was two hundred (200); the number of votes indisputably represented by the unanimous written consent in lieu of a special meeting of the shareholders was two hundred (200).
 - b. The number of shares voted for the amendment was two hundred (200), and the number of shares voted against such amendment was zero (0). The number of votes cast for this amendment by the sole voting group of holders of common stock was sufficient for approval by that voting group.
