

AFFIDAVIT OF DEATH AND HEIRS

Before me, the Undersigned authority, a Notary Public in and for said County and State personally appeared JESSIE SMITHERMAN, who, upon being duly sworn and cautioned to testify truthfully, testified as follows:

- 1. My name is JESSIE SMITHERMAN and my mailing address is 383 Hwy 8 Montevallo, Alabama 35115. I am an adult male over the age of nineteen and am familiar with the family history of James F. Smitherman and Sylvia M. Smitherman.
- 2. I am not related to James F. Smitherman or Sylvia M. Smitherman but have known them all of my life. Accordingly, I am well familiar with the Smitherman family history and can testify truthfully relative to the facts.
- 3. James F. Smitherman and Sylvia M. Smitherman purchased their house and property in February 1982. Their property was purchased jointly but not in survivorship. The deed is dated February 19, 1982 with a true and accurate copy of their deed being attached hereto as Exhibit "A".
- 4. James F. Smitherman and Sylvia M. Smitherman had five children. Their names are as follows:

Larry W. Smitherman; Bobby R. Smitherman; James K. Smitherman; Lisa S. Davis; and, Linda S. Crumpton. Bobby R. Smitherman died in 1997 without children. The remaining four (4) individuals are alive; all are over the age of nineteen and all are of sound mind.

5. James F. Smitherman died on March 19, 1993 and did not leave a will. Sylvia M.

Smitherman died on May 31, 2011 and did leave a will. Attached hereto as Exhibit "B" is a true and accurate copy of her will. Sylvia's estate is currently being probated in Shelby County and is Case No.: PR 2011-000562.

I have no legal interest in the property nor do I have any financial interest in making this affidavit or the resulting ownership of the land. Simply stated, I make this affidavit with knowledge of the family and out of friendship for them.

I, SYLVIA M. SMITHERMAN, a resident of the State of Alabama, being of sound mind and disposing memory, do hereby make and publish this my Last Will and Testament, hereby revoking any former Will and Codicil thereto.

ARTICLE ONE


I direct that all my debts, including the expenses of my last illness and funeral, shall first be paid out of my estate by my Executrix hereinafter named as soon as possible after my death; provided, however, if any real estate which I may own at the time of my death is encumbered by specific mortgage or lien, it is my intention that such indebtedness shall not be charged to or paid from my estate, but that the beneficiary receiving such property shall take it subject to all mortgages and encumbrances existing at such time.

(A) I hereby give, devise, and bequeath all of my estate to

my five (5) children, in equal shares.


(B) In the event one or more of my children should predecease me, the living issue of my deceased child or children shall inherit the deceased child's share of my estate in equal shares. one or more of my deceased children not leave issue surviving, then in that event, my remaining, surviving children shall inherit the deceased child's share of my estate.

ARTICLE THREE

I hereby nominate, constitute, and appoint my daughter, LINDA S. CRUMPTON as Executrix of my estate under this my Last Will and Testament. If LINDA S. CRUMPTON does not act as Executrix, or once appointed resigns, then I hereby nominate, constitute, and appoint my daughter, LISA S. TOMPKINS, as an Alternate or Successor Executrix.

I direct and request that my Executrix shall not be required to give any bond or other security to any Court for the faithful performance of any duties, nor shall said Executrix be required to file an inventory or make an accounting or settlement in any Court. I hereby authorize my Executrix to sell and convey any and all property in my estate at public or private sale without order of Court.

ARTICLE FOUR

The following provision shall govern for all purposes of this Will, wherever it may be applicable:

- (A) As used herein, the term Executrix shall be interchangeable with the term Alternate or Successor Executrix and vice-versa.
- (B) To be found with this My Last Will and Testament will be a handwritten list I have prepared designating specific items of personalty to go to specific persons. I direct that my Executrix distribute my estate and adhere to this handwritten list if at all possible.


