
4. James F. Smitherman and Sylvia M. Smitherman had five children. Their names are as follows:

I, SYLVIA M. SMITHERMAN, a resident of the State of Alabama, being of sound mind and disposing memory, do hereby make and publish this my Last Will and Testament, hereby revoking any former Will and Codicil thereto.

ARTICLE ONE

I direct that all my debts, including the expenses of my last illness and funeral, shall first be paid out of my estate by my Executrix hereinafter named as soon as possible after my death; provided, however, if any real estate which I may own at the time of my death is encumbered by specific mortgage or lien, it is my intention that such indebtedness shall not be charged to or paid from my estate, but that the beneficiary receiving such property shall take it subject to all mortgages and encumbrances existing at such time.

my five (5) children, in equal shares.

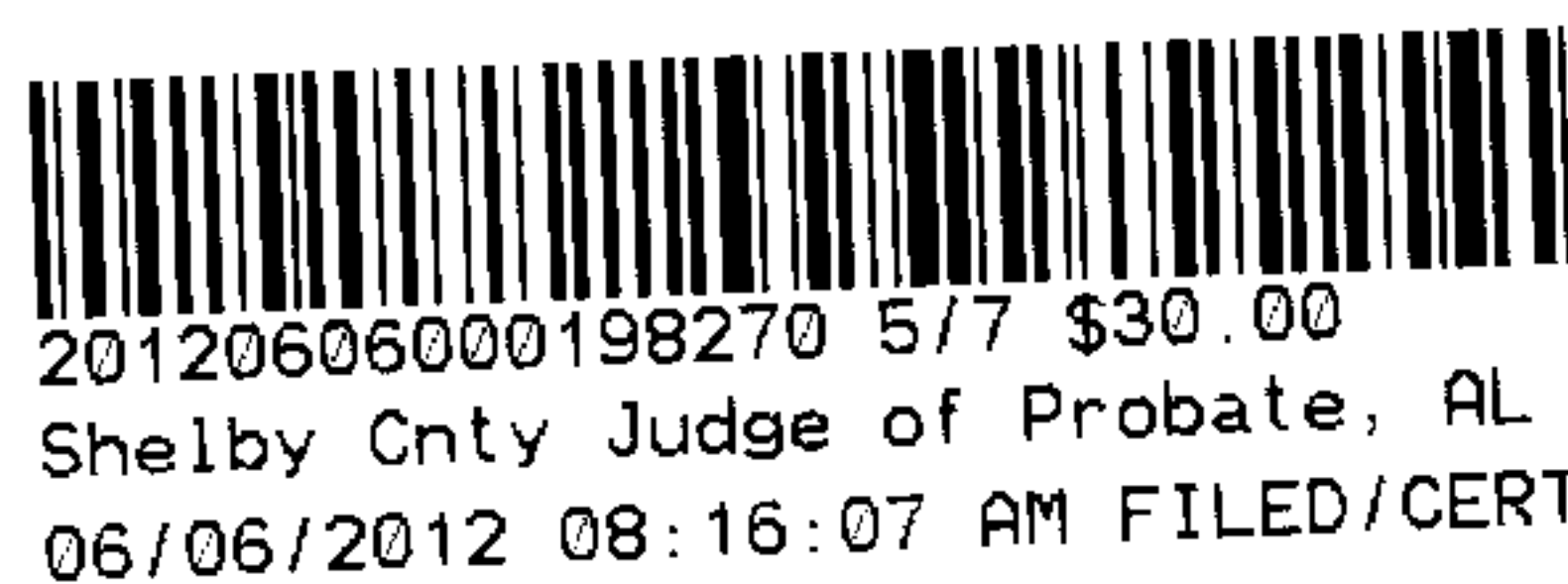

(B) To be found with this My Last Will and Testament will be a handwritten list I have prepared designating specific items of personalty to go to specific persons. I direct that my Executrix distribute my estate and adhere to this handwritten list if at all possible.
