- 3. James F. Smitherman and Sylvia M. Smitherman purchased their house and property in February 1982. Their property was purchased jointly but not in survivorship. The deed is dated February 19, 1982 with a true and accurate copy of their deed being attached hereto as Exhibit "A".
- 4. James F. Smitherman and Sylvia M. Smitherman had five children. Their names are as follows:

Larry W. Smitherman; Bobby R. Smitherman; James K. Smitherman; Lisa S. Davis; and, Linda S. Crumpton. Bobby R. Smitherman died in 1997 without children. The remaining four (4) individuals are alive; all are over the age of nineteen and all are of sound mind.

5. James F. Smitherman died on March 19, 1993 and did not leave a will. Sylvia M.

Smitherman died on May 31, 2011 and did leave a will. Attached hereto as Exhibit "B" is a true and accurate copy of her will. Sylvia's estate is currently being probated in Shelby County and is Case No.: PR 2011-000562.

I have no legal interest in the property nor do I have any financial interest in making this affidavit or the resulting ownership of the land. Simply stated, I make this affidavit with knowledge of the family and out of friendship for them.

ARTICLE ONE


