KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of May, 2007, Judy D. Henson and Larry Henson, wife and husband; Tana M. Henson, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for DHI Mortgage Company, Ltd, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20070606000264590; corrected by scrivener's affidavit in Instrument Number 20080130000038910, said mortgage having subsequently been transferred and assigned to BAC Home Loans Servicing, L.P., by instrument recorded in Instrument No. 20110719000210210, in the aforesaid Probate Office ("Transferee"); and


