

**ARTICLES OF ORGANIZATION

Pursuant to the Provisions of Act No 93-724 of the 1993 Alabama Legislature, as amended, the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

**ARTICLE I
NAME**

The name of the Limited Liability Company is: **CASEY JONES SUNSHINE FARMS, LLC.**

**ARTICLE II
DURATION**

The period of its duration is perpetual.

**ARTICLE III
PURPOSE**

The Limited Liability Company has been organized for the following purposes:

1. To engage in the business of acquiring and managing real estate and making improvements thereon including the creation of farms for profit and/or land development or any other purpose deemed suitable for land acquired or managed by the LLC.
2. To engage in transactions of any and all lawful business which may be incidental and/or beneficial to the Company.
3. To engage in the transaction of any or all lawful business within the State of Alabama.
