ARTICLES OF ORGANIZATION
OF
MILSTER CONSULTING GROUP, LLC

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, hereby certify and adopt the following Articles of Organization:

1. The name of the Limited Liability Company is Milster Consulting Group, LLC.
2. The purpose for which this Limited Liability Company is organized is:

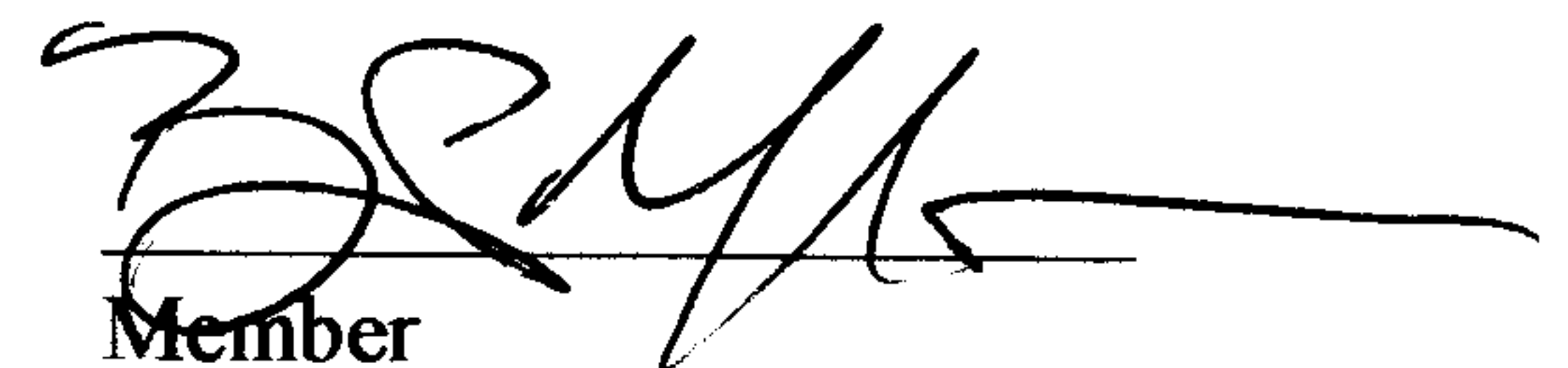

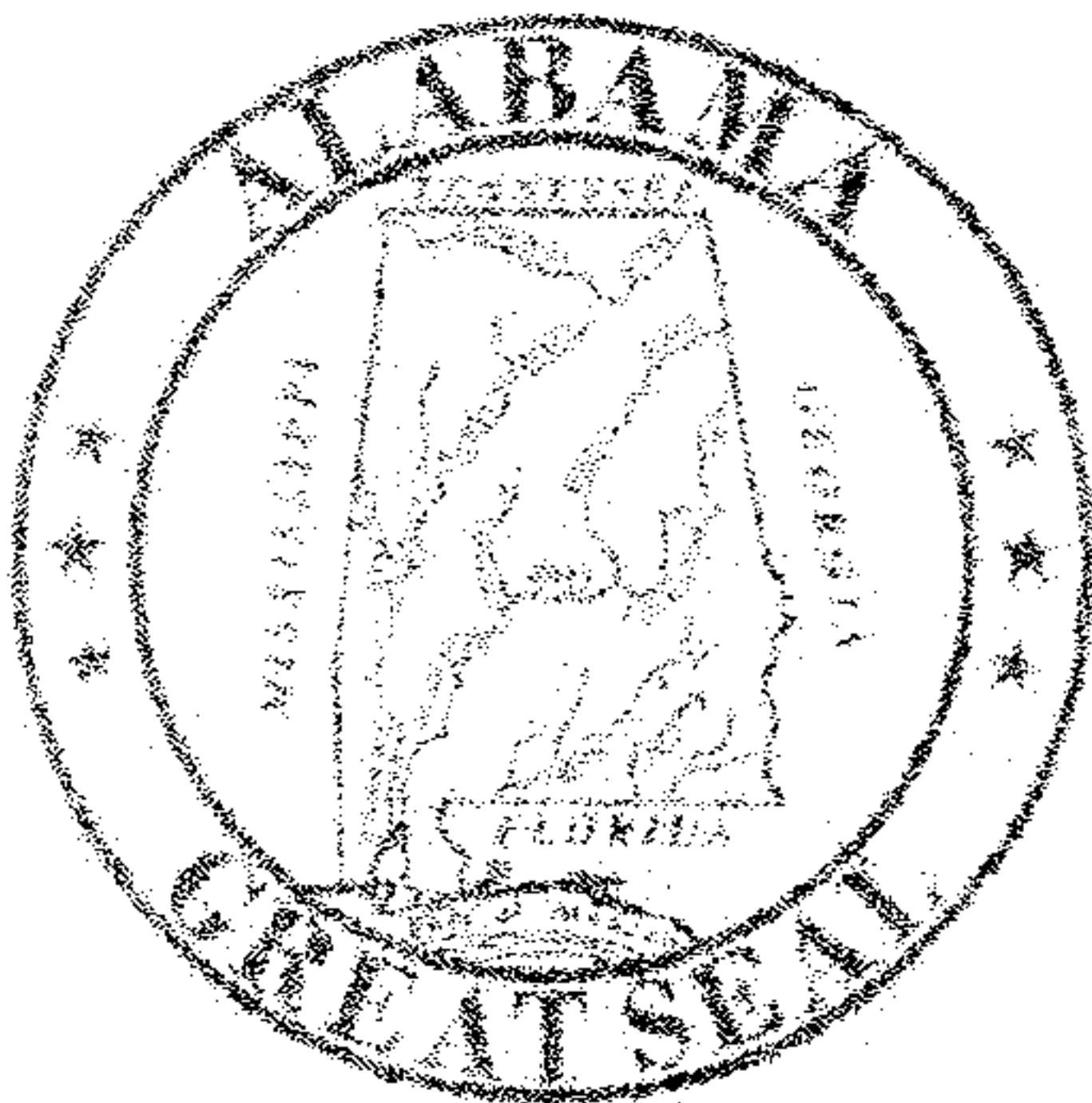
