

**ARTICLES OF ORGANIZATION
OF
AVAST REALTY. L.L.C.**

1. The name of the limited liability company is AVAST REALTY., L.L.C. (the "Company")
2. The period of its duration is perpetual; provided, however, that the Company shall cease to exist upon dissolution of the Company in accordance with Section 10-12-37 of the Code of Alabama of 1975, as amended.
3. The purposes for which the Company is organized are (I) to acquire, own, sell or exchange real property or any interest therein, and (II) to engage in the transaction of any and all lawful business for which a Company may be organized under the Alabama Limited Liability Company Act.
4. The location and mailing address of the initial registered office of the company is 4518 Valleydale Road, Suite 203, Birmingham, AL 35242. The name of its initial registered agent at that address is Randy Brooks
5. The names and mailing addresses of the initial members of the Company are as follows:

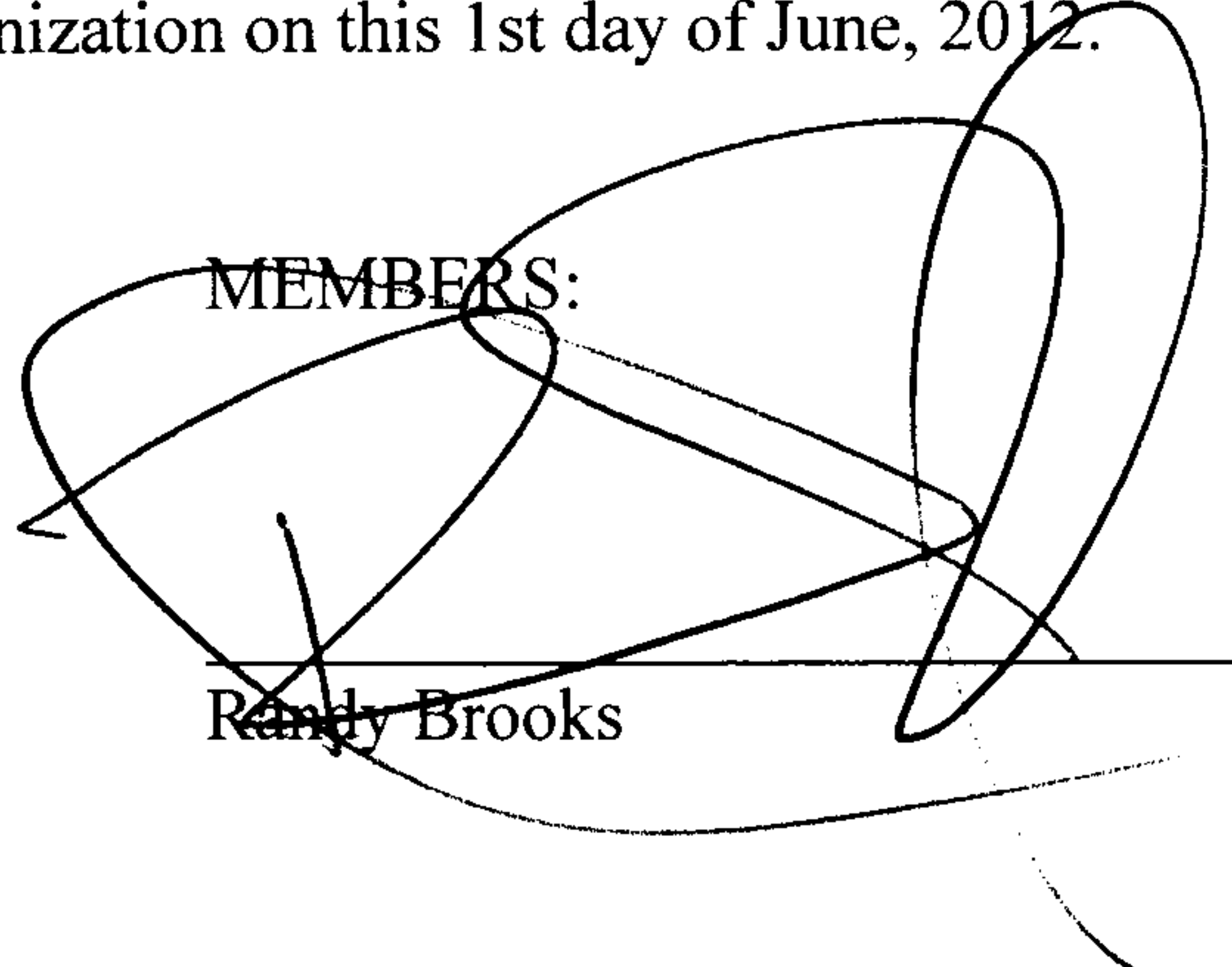
