Pursuant to the Alabama Limited Liability Company Law, the undersigned hereby adopts the following Articles of Organization:

1. The name of the limited liability company is ABJC Real Estate, LLC (hereinafter referred to in this Certificate of Formation as the "Company").

2. The purpose for which the Company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Law.

3. The period of its duration is perpetual.

Prior to the adoption of an Operating Agreement, the initial members shall have the right to admit additional members to the Company upon the written consent of the all of the initial members of the Company. Thereafter, the initial members shall have the right to admit additional members to the Company in accordance with the terms and conditions of the applicable provisions of the Operating Agreement of the Company. All members of the Company shall be licensed or registered to provide the professional services for which the Company is organized.

7. Except as specifically required by any non-waivable provisions of the Alabama Limited Liability Company Law or any provisions of the Operating Agreement of the Company, the cessation of membership in the limited liability company by any member shall not result in the dissolution of the limited liability company.

8. Management of the Company shall be vested in one or more managers. There shall be one (1) initial manager of the Company, and the name and address of the individual who is to serve as such initial manager until his successor is elected and begins serving are as follows:

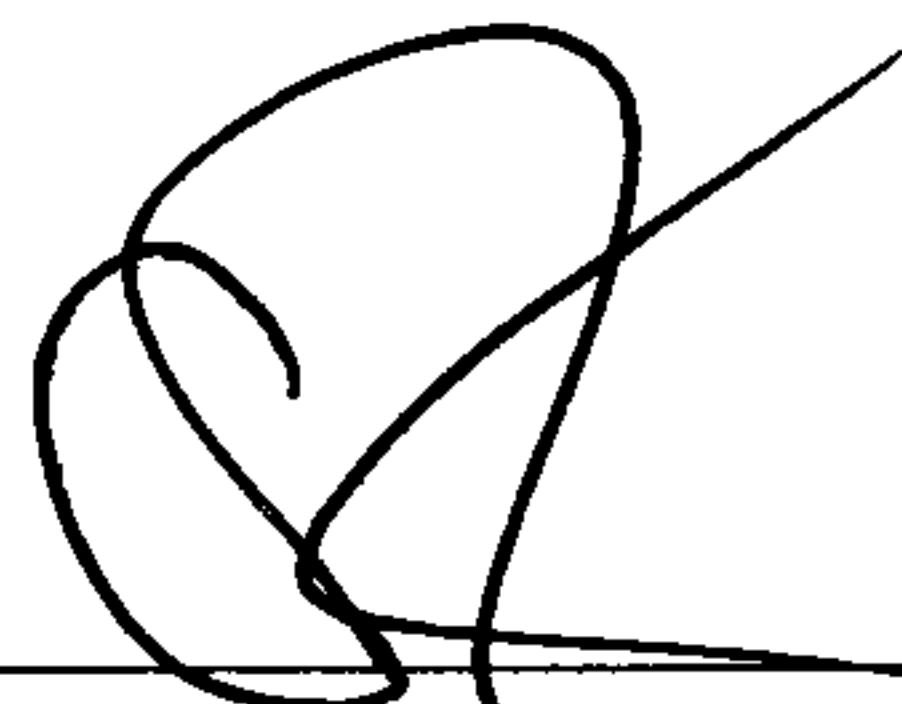
9. The regulation of the internal affairs of the Company, if not set forth herein, shall be governed by the Operating Agreement of the Company which may be in effect from time to time.
