Articles of Organization of Bucks Pizza of Alabaster, LLC


(Member-Managed)

Pursuant to the provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

- Name. The name of the limited liability company is Bucks Pizza of Alabaster, LLC (the *i Companyî*).
- Duration. The duration of the Company shall be perpetual.
- Purposes. The purposes for which the Company is formed are: (a) to provide a dine in and carry out restaurant service and local deliveries, (b) to purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, companies, limited liability companies, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof; and (c) to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Alabama Limited Liability Company Act, as amended.
- Registered Office; Registered Agent. The location and street address of the initial registered office of the Company shall be 1103 MacQueen Circle, Helena, Alabama 35080, and its registered agent at such address shall be Randall E. Spradlin.
- Initial Members. The rights, powers and duties of all of the Members are set forth in the Operating Agreement by and between the Members of the Company. The name and address of the initial Member is Randall Spradlin, 1103 MacQueen Circle, Helena AL 35080.
- Organizer. The name and address of the Organizer is Randall Spradlin 1103 MacQueen Circle, Helena, Alabama 35080.
- Admission of Additional Members. Additional Members may be admitted in accordance with the terms of the Operating Agreement of the Company.
- Cessation of Membership. The cessation of membership of one or more Members will not result in the dissolution of the Company.


