6. I give this Affidavit of my own personal knowledge.

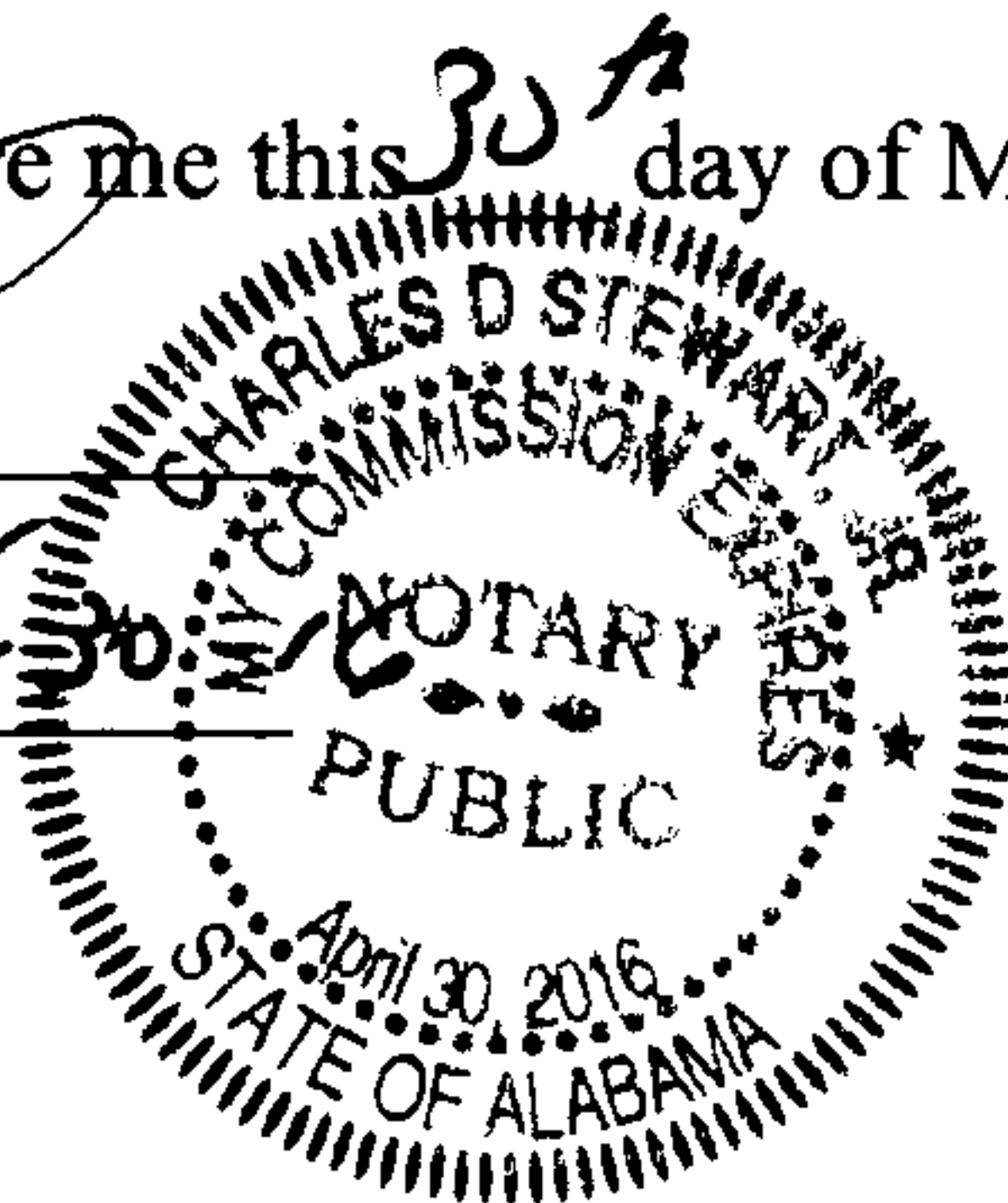
