That for and in consideration of the sum of Ten and No/100 Dollars, and other good and valuable consideration, in hand paid to the undersigned, Rhonda Carol Spratlin Daniel, Personal Representative of the Estate of Willodean Vivian Spratlin, deceased (hereinafter referred to as the "Grantor"), the receipt of which is hereby acknowledged, the Grantor does hereby grant, bargain, and convey unto Roger Hugh Spratlin, a married person, an undivided 1/2 interest, and Rhonda Carol Spratlin Daniel, a married person, an undivided 1/2 interest (hereinafter referred to as the "Grantees"), in the following described real estate situated in Shelby County, Alabama, to-wit:

E1/2 of SE1/4 of SE1/4 of Section 18, Township 20, Range 1 West, lying North of Highway; containing 20 acres, more or less; less and except the following, a portion thereof:


