The undersigned adopt the following Articles of Organization for the purpose of forming a limited liability company under the provisions of Act No. 93-724 of the 1993 Alabama Legislature, as amended, and known as the Alabama Limited Liability Company Act (the "Act"):

**ARTICLE I
NAME**

The name of the limited liability company, referred to in these Articles as "Company," is "OAK MOUNTAIN PRESS, LLC."

**ARTICLE II
DURATION**

The period of duration of the Company is perpetual beginning on the date these Articles of Organization are dated at the end hereof unless sooner dissolved.

**ARTICLE III
PURPOSE**

The purposes for which the Company is organized are publishing books and magazines in electronic and traditional formats and to publish blogs, webzines, and website, and to conduct any lawful business for which limited liability companies may be organized under the Act as may be specifically authorized by the members.

**ARTICLE IV
REGISTERED AGENT AND OFFICE**

The name of the Company's initial registered agent in Alabama is Steven P. Gregory. The address and location of the Company's registered office in Alabama and the address of the said agent is 270 Doug Baker Blvd., Suite 700-305, Birmingham, AL 35242.

**ARTICLE V

**ARTICLE VI
NEW MEMBERS**

The members shall have the right to admit additional members, upon the terms and conditions specified by the then member or members. A member shall not have the right to transfer his rights to be a member, although a member shall have the rights of assignment of financial rights as provided and limited by the Act.

**ARTICLE VII
DISSOLUTION**

The Company shall be liquidated and dissolved if an event of dissociation terminates the continued membership of a member in the Company. The Company shall also be dissolved at any time upon the action of the member or members.

**ARTICLE VIII
INITIAL MANAGERS**



The initial manager of the Company is Steven P. Gregory.

MISCELLANEOUS MATTERS**
