SCOTT, JR., and VICKIE L. SCOTT, husband and wife** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **DANNY G. BOST and TAMMY L. BOST** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 31, according to the Survey of Stonegate Realty, Phase Two, as recorded in Map Book 31, page 28 A & B, in the Probate Office of Shelby County, Alabama.

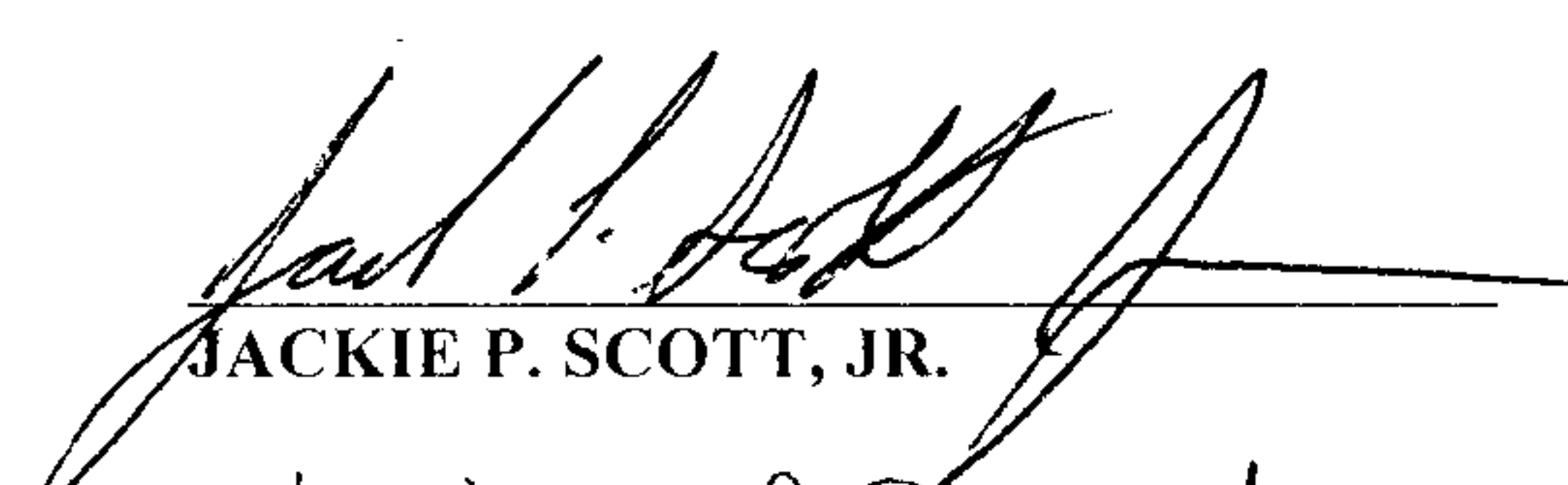
Subject to all restrictions, reservations, rights, easements, rights-of-way, provisions, covenants, terms, conditions and building set back lines of record, if any.

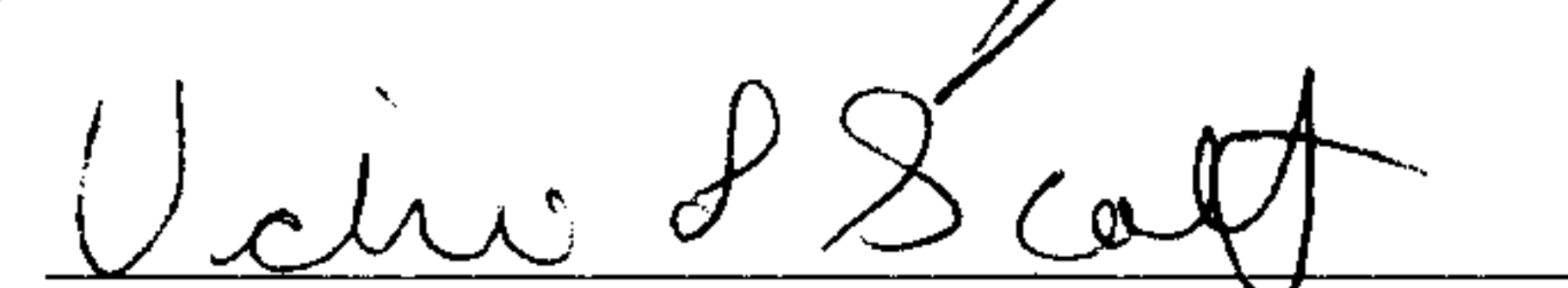
\$790,000.00 of the above-recited consideration is being paid in cash.

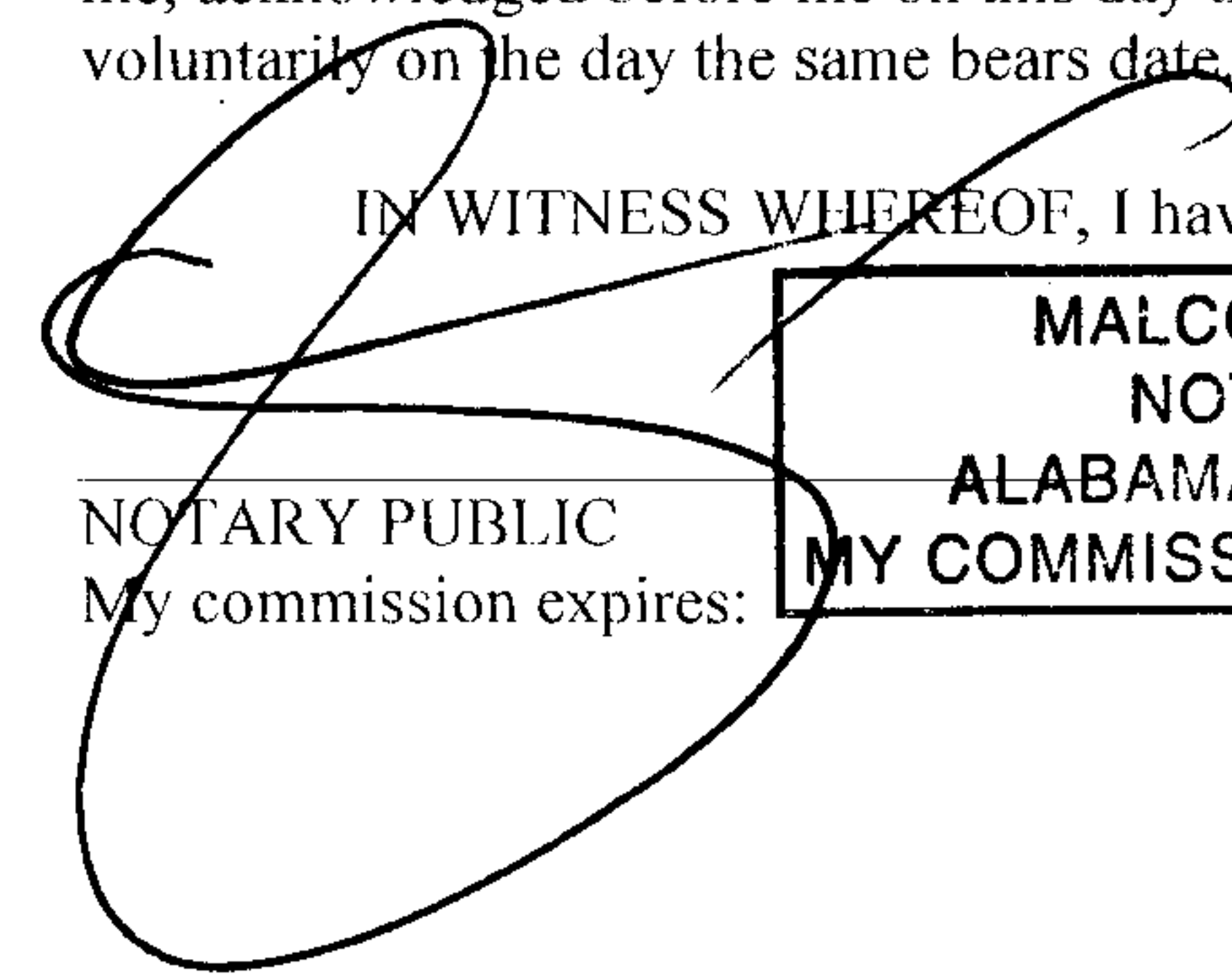
