That in consideration of Three Hundred Thousand and 00/100 Dollars (\$300,000.00) to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

Danny L. Williams and his wife Vicki S. Williams

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Mitchell G. Frank and Jean M. Frank

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 6, according to the Survey of Skyline Estates, First Sector, as recorded in Map Book 9, Page 71, in the Probate Office of Shelby County, Alabama.


\$276,550.00 of the proceeds come from a mortgage recorded simultaneously herewith.

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.




