

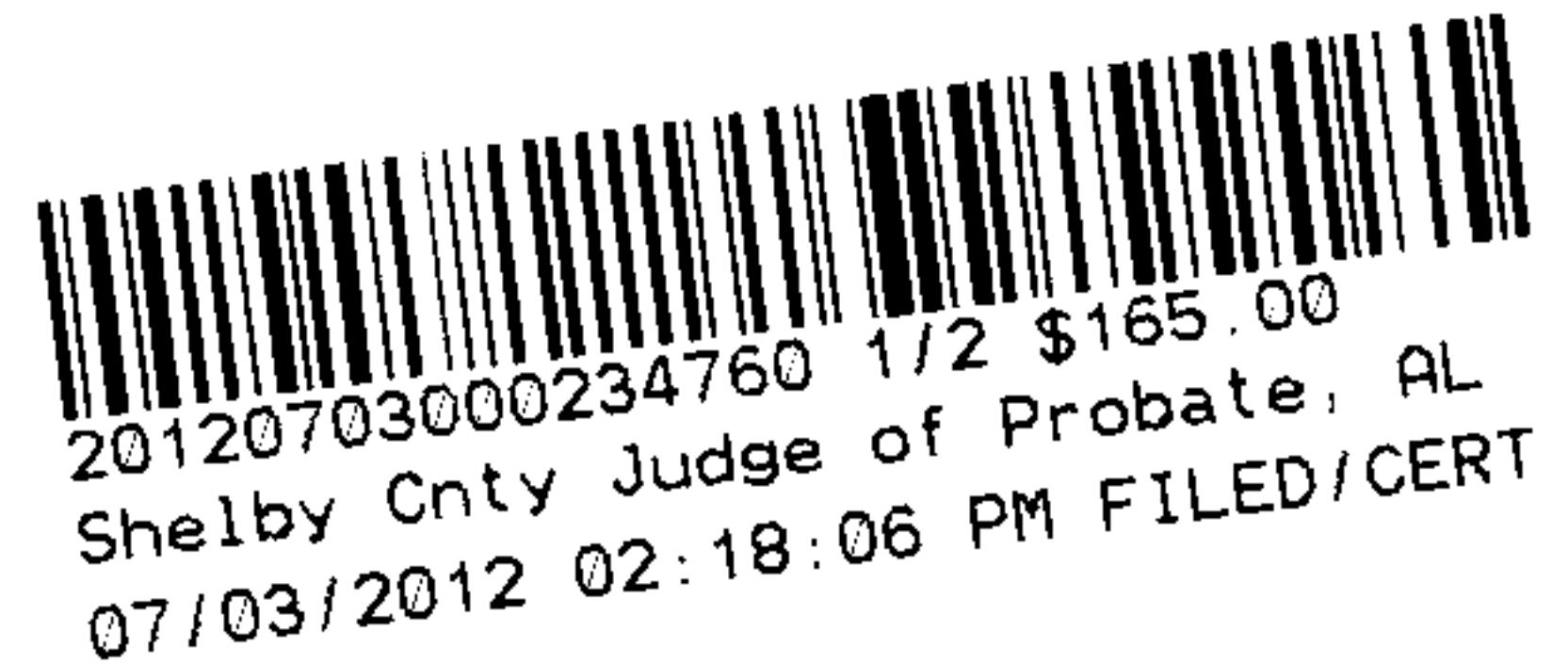

DAUBER** (herein referred to as Grantor, whether one or more) do grant, bargain, sell and convey unto **THE DAUBER FAMILY REVOCABLE TRUST**, herein referred to as Grantee, in fee simple, together with every contingent remainder and right of reversion the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

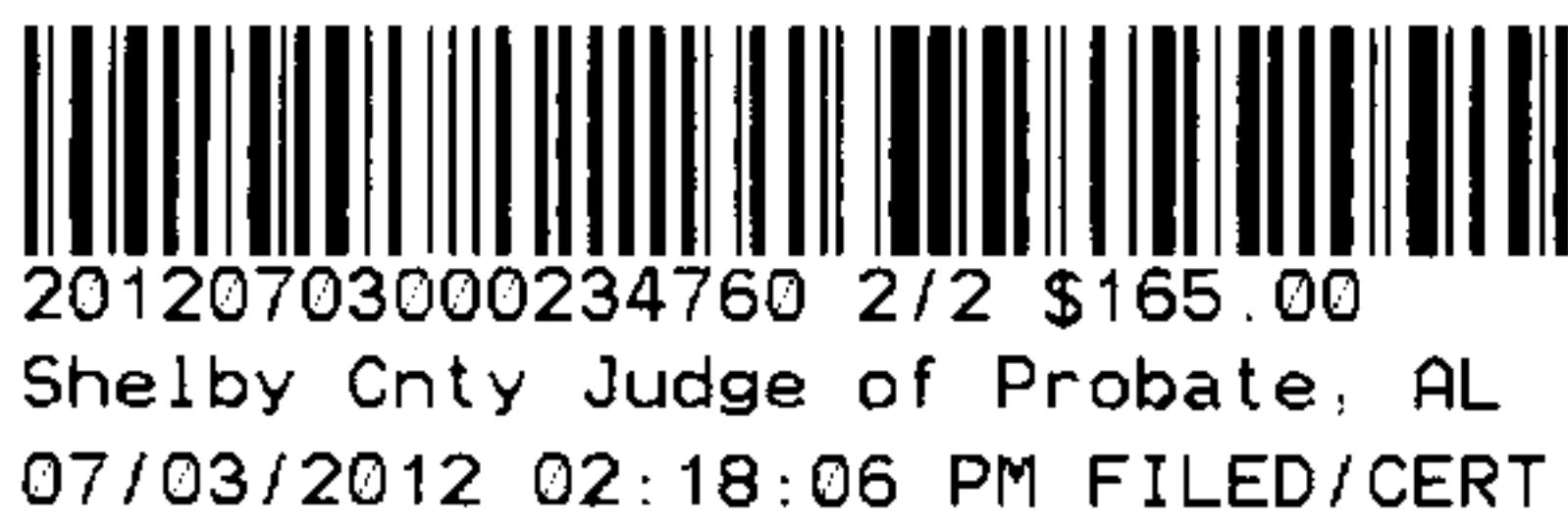
