

**ARTICLES OF INCORPORATION  
OF  
ALABAMA AUTOMOTIVE REPAIR INDUSTRY SOCIETY OF EXCELLENCE  
an Alabama Nonprofit Corporation**

For the purposes of forming a Nonprofit Corporation under the laws of the State of Alabama, and pursuant to the provisions of Sections 10A-1-3.05, and 10A-3-3.02 of the 1975 Code of Alabama, as amended, the Articles of Incorporation of Alabama Automotive Repair Industry Society of Excellence are as follows:

**ARTICLE I**

**NAME**

The name of the Nonprofit Corporation is: Alabama Automotive Repair Industry Society of Excellence

**ARTICLE II**

**DURATION**

The Nonprofit Corporation shall have perpetual duration.

**ARTICLE III**

**PURPOSE**

The Nonprofit Corporation is organized in order to engage in any lawful purpose or purposes not for pecuniary profit, initially specifically those purposes designated in Section 10A-3-1.04 (4), (7) and (18), of the 1975 Code of Alabama, as amended; the purpose also includes the transaction of any lawful business for which nonprofit corporations may be incorporated in Alabama under Title 10A, Chapter 3 of the 1975 Code of Alabama, as amended.

**ARTICLE IV**

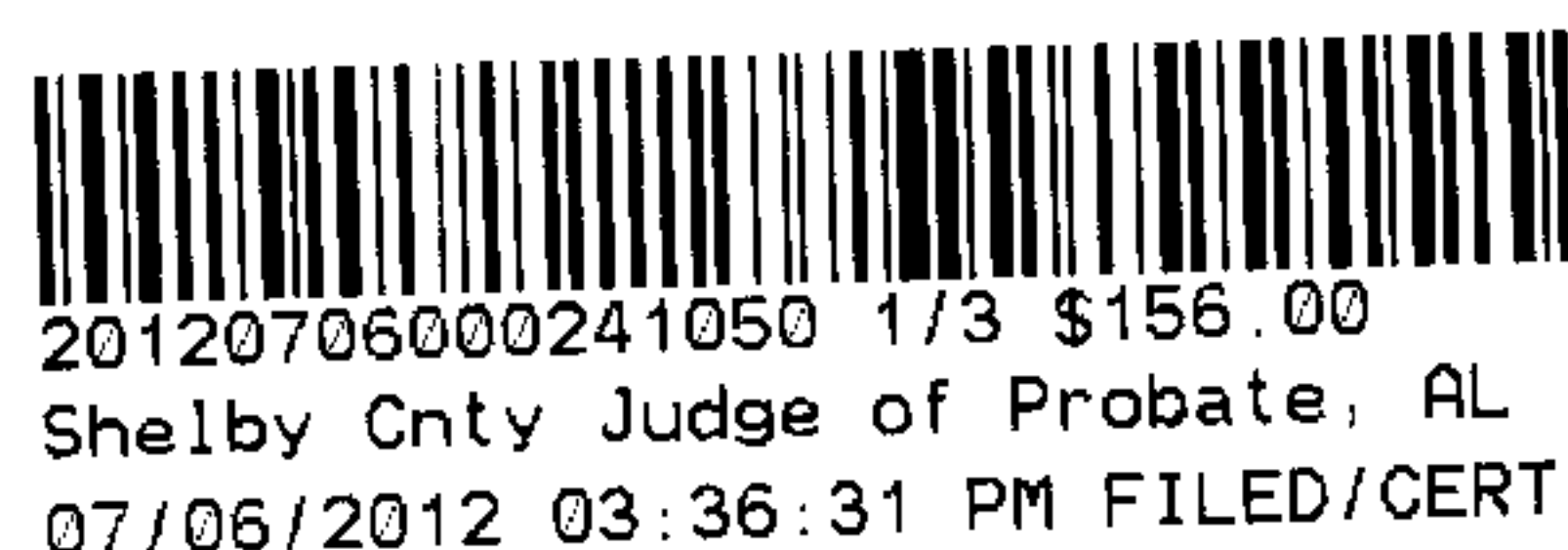
**MEMBERS**



After the filing of these Articles, the number of directors may be changed from time to time in the manner set forth in the bylaws of the Corporation.

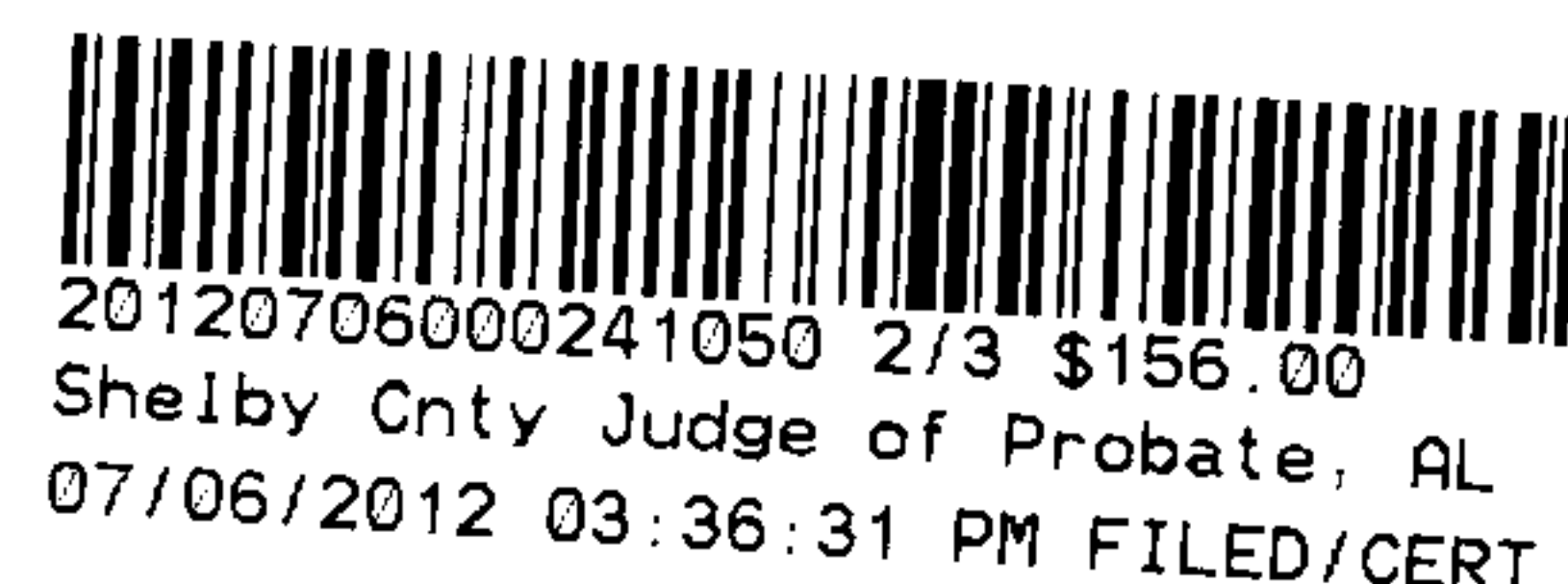
