

ORDER FOR REFORMATION

This matter comes before this Court on Bank of America, National Association as Successor by Merger to LaSalle Bank National Association, as Trustee Under the Pooling and Servicing Agreement Dated as of May 1, 2006, GSAMP Trust 2006-HE3's Motion for Default Judgment. Defendants Gary L. Morgan and Amy L. Morgan having been served on May 3, 2011, but failing to respond or otherwise defend this action, this Court **ORDERS**, **ADJUDGES**, and **DECREES** as follows:

This Court having considered same, and after determining that there exists no genuine issue of material fact, this Court determines that Plaintiff is entitled to judgment as a matter of law. Plaintiff Bank of America, National Association as Successor by Merger to LaSalle Bank National Association, as Trustee Under the Pooling and Servicing Agreement Dated as of May 1, 2006, GSAMP Trust 2006-HE3's Motion for Default Judgment is hereby GRANTED.



That the Power of Attorney attached to Plaintiff's Complaint as Exhibit "A" was valid and in force at all times on January 11, 2006, at which time Amy Morgan validly executed the subject Mortgage and Note.

That the Mortgage (Exhibit "B" to Plaintiff's Complaint) securing the Note and the Note (Exhibit "C" to Plaintiff's Complaint) in the amount of \$92,800.00 are hereby declared valid in all respects.

That said documents were validly executed both by Amy Morgan and by Amy Morgan, as Attorney in Fact for Gary Morgan.

The court makes no determination as to the validity of the post execution assignments, the subject Pooling and Servicing Agreement, or the compliance with the terms of any referenced trust.

That all costs are taxed as paid.
