Whereas, on the 6<sup>th</sup> day of April, 2009 a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **CURRAN DANIEL E & MALISSA K**, the owners of said land for the costs and expenses thereof and thereunder.
