
## IN THE PROBATE COURT OF SHELBY COUNTY, ALABAMA

## KNOW ALL MEN BY THESE PRESENTS, THAT

Whereas, on the 6th day of April, 2009 a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from GRIFFIN EDDIE RANDALL, the owner of said land for the costs and expenses thereof and thereunder.
