
## CERTIFICATE OF FORMATION

Pursuant to the provisions of Alabama Code §10A-1-1.01 <u>et seq</u>, the undersigned hereby submits the following Certificate of Formation of a Limited Liability Company.

- I. NAME. The name of the Limited Liability Company is A-GANG MECHANICAL, LLC (hereinafter the "Company").
- II. DURATION. The duration of the Company shall be perpetual.
- III. <u>PURPOSE</u>. The purpose of the Company is to own and operate a heating, air conditioning, refrigeration, and gas business, and the transaction of any and all other lawful purposes.
- IV. <u>LOCATION</u>. The location and mailing address of the Company's initial registered office is 100 Shady Hill Circle, Calera, Alabama 35040, and the name of the Company's initial registered agent at that address is Don Seiberling.
- V. <u>ADMISSION OF ADDITIONAL MEMBERS</u>. No member of the Company has the right to admit additional members, except as provided in the Company's Operating Agreement.
- VI. <u>MANAGEMENT</u>. The Company is to be managed by one or more managers, and the name and mailing address of the initial manager of the Company is:

The initial manager shall serve as manager of the company, until the members shall elect a successor, and such successor be duly qualified.

- VII. <u>LIMITED LIABILITY OF MEMBERS</u>. Except as provided by <u>Ala. Code</u> § 10A-5-3.02 or other applicable law, the members of the Company shall not be liable under a judgment, decree, or court order, or in any other manner, for a debt, obligation, or liability of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of Company.
- VIII. <u>CONTINUATION OF BUSINESS UPON DISSOCIATION OF A MEMBER</u>. If a member of the Company becomes dissociated from the Company, pursuant to this Certificate, the Operating Agreement, or by operation of law, the Company's affairs shall be

wound up, and the Company dissolved, unless the remaining members submit their unanimous written consent within ninety (90) days of dissociation, and there exists at least one remaining member.
