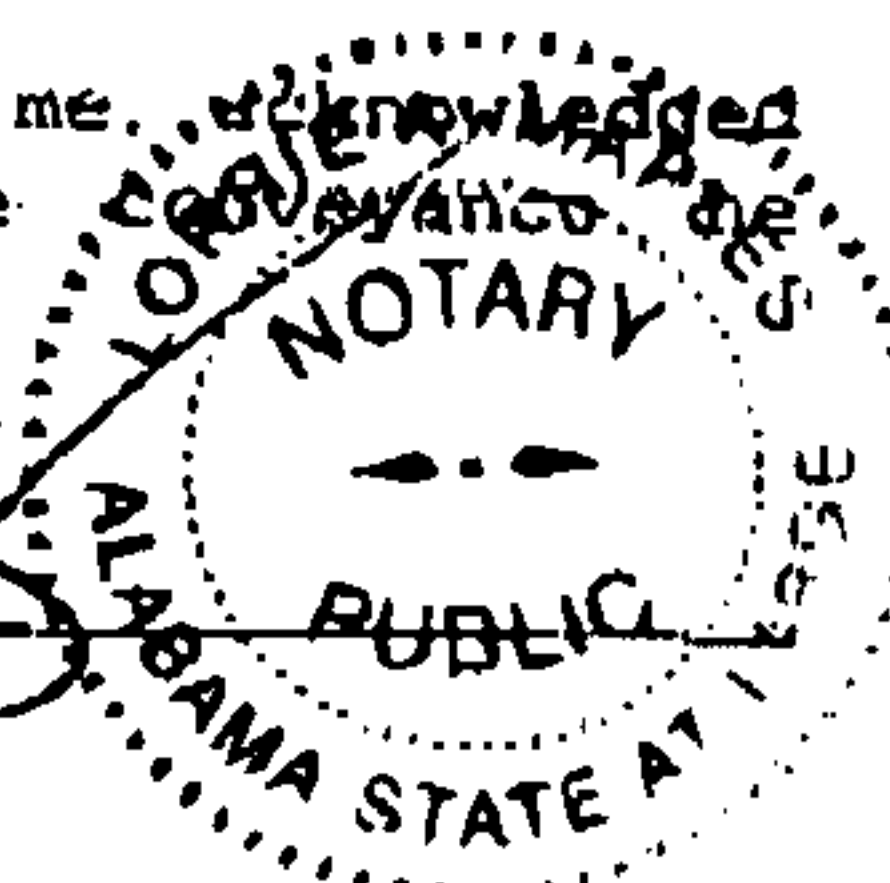


EXHIBIT "A"

Commencing at the NW corner of Section 13, Township 21 South, Range 1 East; thence East along the North line of said Section, a distance of 1100.16 feet to a point on the Northeast edge of the Lokey-Ferry Road; thence South 40 degrees 10 minutes 03 seconds East along the Northeast edge of said road, a distance of 217.31 feet to the Point of Beginning; thence South 71 degrees 50 minutes 48 seconds East a distance of 398.02 feet; thence South 3 degrees 14 minutes 00 seconds West a distance of 148.93 feet; thence North 67 degrees 43 minutes 17 seconds West a distance of 280.39 feet to the easterly right of way line of Lokey-Ferry Road, also a point on a curve to the left having a central angle of 11 degrees 52 minutes 52 seconds and a radius of 566.54 feet, said curve subtended by a chord bearing North 31 degrees 02 minutes 01 seconds West and a chord distance of 121.41 feet; thence along the arc of said curve and along said right of way a distance of 121.63 feet; thence North 35 degrees 58 minutes 27 seconds West along said right of way a distance of 79.32 feet to the Point of Beginning, Shelby County, Alabama.
