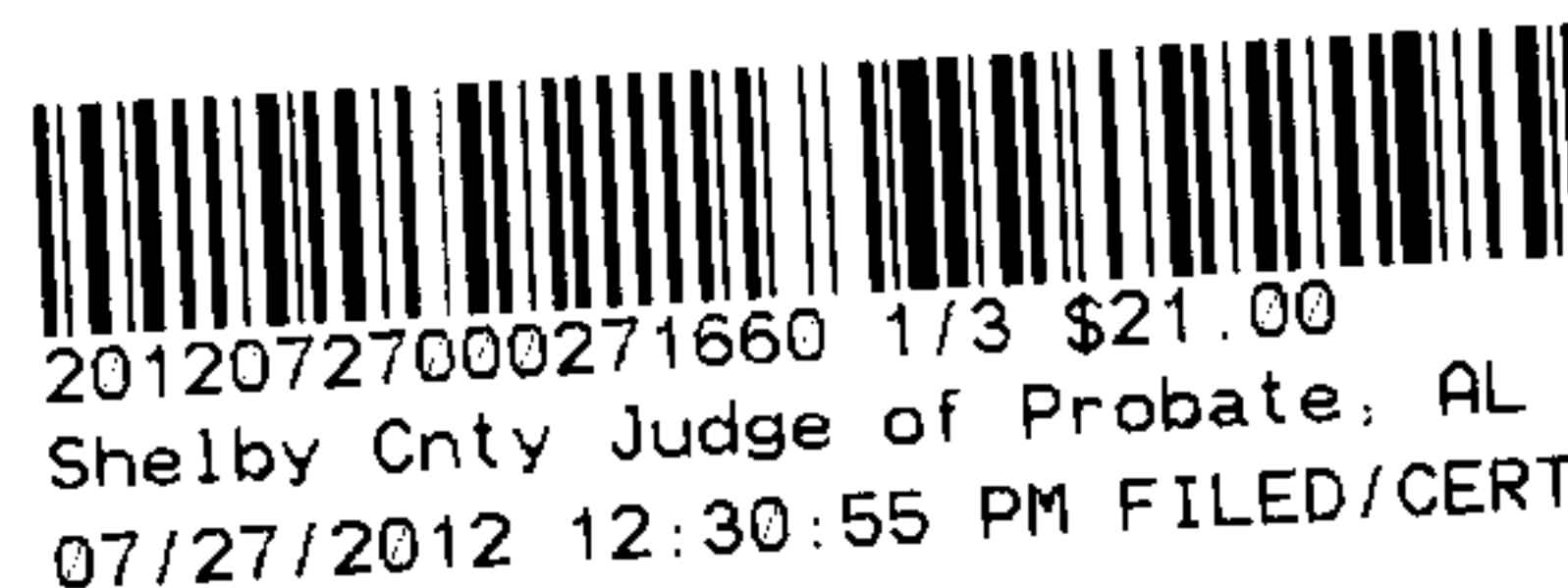

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of May, 1994, Gary A. Clouse, a single individual, executed that certain mortgage on real property hereinafter described to South States Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1994-15324, said mortgage having subsequently been transferred and assigned to NationsBanc Mortgage Corporation, by instrument recorded in Instrument Number 1994-15325, in the aforesaid Probate Office ("Transferee"); and

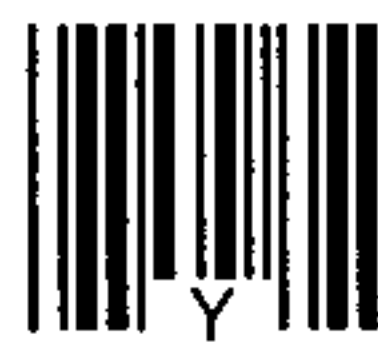
