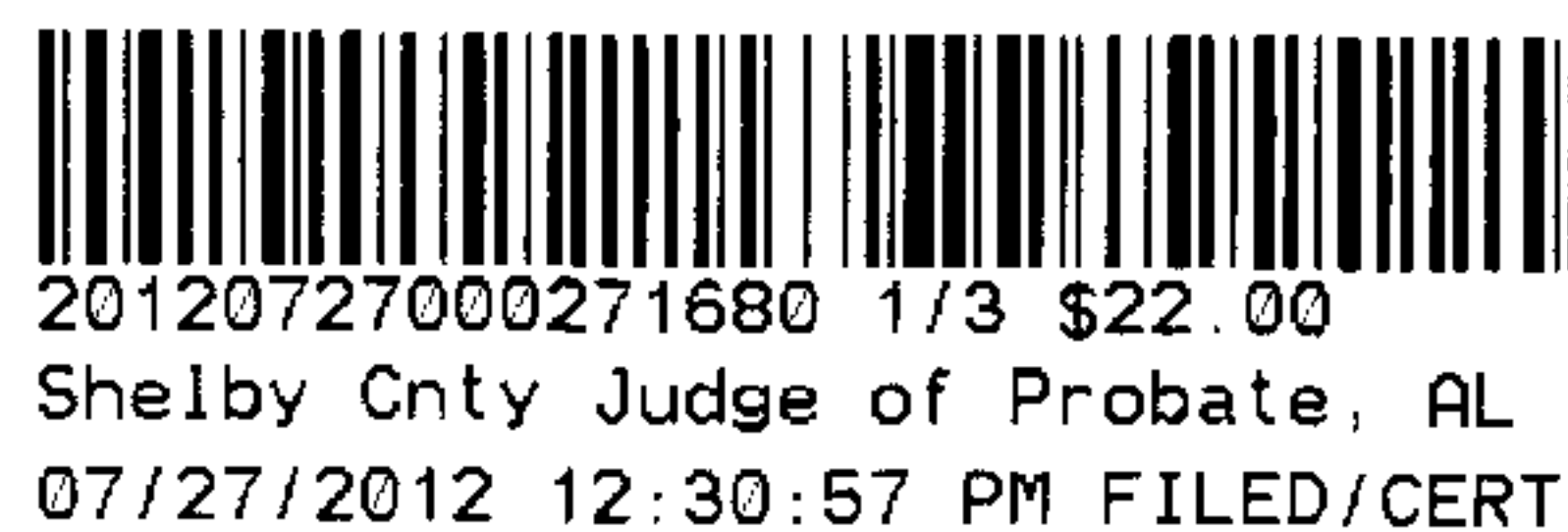
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of October, 2005, Stephen Hamile, a married man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for Countrywide Home Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051102000570240, said mortgage having subsequently been transferred and assigned to HSBC Bank USA, National Association, as Trustee for the Holders of the GSAA Home Equity Trust, 2005-15, by instrument recorded in Instrument Number 20120523000183840, in the aforesaid Probate Office ("Transferee"); and
